GOVT Prones All Agencies

he Government The Bahamas has made the decision to conduct thorough investigation of all agencies and departments with a view to stamp out corruption and malfeasance.

During yesterday's weekly press briefing, Press Secretary Anthony Newbold said all government agencies are under investigation and review, as he responded to questions raised by members of the public after the unveiling of a special list at both the Bahamas Power and Light and the Water and Sewerage Corporation.

"When the prime minister took office he said every government department and ministry is going to be reviewed," Newbold said.

He added that there is going to be a comprehensive review of every single department which could take the form of an audit or just general review.

"That is what has happened in the case of BPL. And concerning Water and Sewerage, it's not a thing where because of the revelations last week the government or Cabinet said let's do an investigation over here," Newbold said.

He added that because of the reviews being done they found some "suspicious" issues.

Newbold said Prime Minister Dr. Hubert Minnis has not spoken to the fact that the former prime minister and deputy prime minister were on the alleged Water and Sewerage list as revealed by the Tribune.

"He does not care or want to know who is on the list. No one should be on the list. There shouldn't be a list to begin with," Newbold said.

TWO MEN CHARGED WITH MURDER

Two young men spent their first night at the Bahamas Department of Correctional Services last night after being arraigned in the Magistrate's Court on separate murder charges yesterday.

Appearing before Deputy Chief Magistrate Andrew Forbes, 25-year-old Kyle Farrington was charged with intentionally causing the death of Fredric Ramsey.

It is alleged that Farrington, while being concerned with another, Shaquille Austin, intentionally caused the death of Ramsey who was killed on September 7, 2017.

In the second arraignment, 23-yearold Lethario Davis, stood accused of the 2015 murder of Alfred Delancev, AKA Donkey, who was shot and killed while attending a party in Fox Hill.

It is alleged that on Sunday, July 27, 2015, Delancey, was approached and shot several times while at a party at on Edgecombe Terrace.

Delancey received multiple gunshot wounds and was rushed to hospital in critical condition. He later died of his injuries.

Both men were not required to enter a plea and was subsequently remanded to the Bahamas Department of Correctional court on November 9, to be serviced with

Dominican **Deal Reactions** Surprises PM

'NO' to GBRHA's Lead on 'SPY BI

The government has declined the Grand Bahama Human Rights Authority's (GBHRA) suggestion for the organization to take the lead on the proposed Interception of Communications Bill.

In yesterday's weekly press briefing, Press Secretary Anthony Newbold said the government will take the lead as far as consultation in regards to the proposed leg-

"As far as the Interception of Communications Bill and the Grand Bahama Human Rights Authority in letting them take the lead on it the answer is no,' Mr. Newbold said.

"The government will not abdicate it's responsibility certainly in something as serious as that.

"There will be widespread consultation and public consultation, but the government is going to take the lead on that and that's how its going to go."

In February, Fred Smith, QC, GBHRA president, warned that in its current form, The Bahamas' proposed Interception of Communications Bill 2017 (known locally as 'The Spy Bill') will violate every citizen's constitutionally protected right to privacy and strike a mortal blow to civil liberties in general.

Since those lists came out, Philip Davis, leader of the official opposition, released a statement explaining that the allegations concerning his business and residence high bills are false.

While accepting that effective law enforcement requires modern surveillance capacities, Mr. Smith noted that in its current form, the bill is extreme, draconian and will lead to a situation in which "nobody's intimate life will be free from scrutiny anymore."

He said in order to strike a balance between law enforcement and civil liberties, there must be "deliberate consultation, thought ... proper time for people to consider it, to look at what legislation has been proposed in other jurisdictions, how its working in other countries, to what extent it has or has not been abused."

He called on the state to desist from its current effort to rush the bill through parliament without public consultation or information sharing.

Smith warned that there is great potential for abuse of this law - particularly in light of the recent illegal

attacks by the current regime on civil society actors.

Last year, former Minister of Education Jerome Fitzgerald was fined \$150,000 by the Supreme Court of The Bahamas for disclosing the private correspondence and financial information of environmental advocates Save The Bays (STB) in an effort to denounce the group as a clandestine political organization seeking to "destabilize the govern-

"The prime minister has been surprised that the offer for students of Dominica to receive education received that kind of reaction," Mr. Newbold said.



Minister Outlines Key Ways to Improve Financial Services Sector

Minister of Financial Services Brent Symonette said more has to be done to improve the country's second industry.

While delivering address at the kevnote Bahamas Financial Services Board (BFSB) meeting held September 20, 2017 at the British Colonial Hilton, Minister Symonette outlined some of the government's objectives.

"Over the past few months as the new minister of financial services, I have recognized that there is a critical need to enable the financial services industry to operate more efficiently," said the minister.

And this efficiency, according the minister, would be achieved if the government implemented several measures including resourcing and restructuring the government agencies that provide support.

Mr. Symonette said by allowing for a more "competitive" environment through legislative reform and the development of new products and services in an environment that is customer friendly, The Bahamas would have a comparative or superior edge to competing jurisdictions.

He also pointed to the easing of the immigration process so that it is more business friendly, timely and efficient in order to prevent the hindrance of operations as to allow options that make it feasible for investors to choose The Bahamas not only for business purposes, but also as a place to reside.

He said it is also of paramount importance a change takes place in the way that business is conducted in the country.

"It is clear that what we are doing is not enough. We cannot continue to do things the same way and expect different results. We have to open our minds and The Bahamas must find ways to open its doors to a global economy that allows professional exchanges that foster growth. And by this, I mean the exchange of legal expertise in certain areas like trust, arbitration, maritime and other financial services aspects. We must be forward thinking to open our economy so that we can advance ourselves. We must do this to survive," said Mr. Symonette.

He explained that there are many untapped opportunities out there and that the Ministry of Financial Services and Investments "is open" to listening to the voices of the private and public sectors in order to devise solutions to drive change and provide opportunities to grow the economy.

"My ministry has met with numerous entities over the past several months, and I can say that the universal challenge facing the industry has been centered heavily around the increased pressure from global regulatory bodies such as the OECD, the need to focus on the ease of doing business in The Bahamas and the enhancement and integration of government departments through advanced tech-

Show them the money and they then proceeded to do their thing; and do it they did!


When they were done with their efforts, more and more of their students left school alienated from self; poorly socialized and in many cases, with their eyes bleeding red with

Heartbroken Grandmother Remembers 'EJ'

After hearing gunshots outside her house, Ms. Murphy faced the gruesome scene of her grandson's bloodied body lying in the arms of his grieving mother, who was wailing at the top of her lungs.

"I only heard the gunshots because I was in the house. Then I heard a lady screaming and then I came outside to go over there to see what went down and I saw he was shot. EJ had gotten shot and his mommy brought him outside to carry him to the car to take him to the hospital," Ms. Murphy told The Bahama Journal yesterday.

Barely able to express her state of mind during the pain, Ms. Murphy said after she realized what happened, she started screaming.

Ms. Murphy said her grandson had a beautiful personality.

"That's one little boy, he's a very nice little boy, anything you tell him do, he does it," she said.

According to Ms. Murphy, the man who was also shot on Monday ran through their backyard trying to evade the bullets.

"He came through the back way and came running through the yard. They didn't even see no bullet where the bullet went straight through the house with their daddy sitting right in the front door and they duck and run for cover," she said.


Although Ms. Murphy and her family received a warm welcome from neighbors, she said violence cannot be ignored.

Perplexed as to why something like this would happen to an innocent child, Ms. Murphy still showed a merciful heart.

"We understand that it is an accident, but it is not fair and he hasn't even started life yet," Ms. Murphy said.

Rosebud Road, Farrington Road, where the murder occurred, is known as a crime riddled area.

Also expressing grief over Eugene's death was Albury Sayle Primary School Principal Katherine Rose.

was devastated. Eugene left school yesterday (Monday) with his ice-cream cone. He went with his best friend across to Bamboo Shack where he waited for his grandmother. We didn't know that yesterday would be the last time that Eugene would be with us," Ms. Rose said.

She also described Eugene's beautiful spirit.

"Little darling, little boy, always wanted a hug, a beautiful spirit. We know that he may be absent from us, but he is present with the Lord with angels surrounding him and I pray for encouragement for his mother as she goes through this trying time," Ms. Rose said.

Students and administrative staff at Albury Sayle Primary School were as equally traumatized by the senseless killing of Eugene.

Speaking with reporters, Ms. Rose shared the school's strategy to help with the school's bereavement through counseling for teachers and students by providing 'special grieving' counseling for everyone on campus.
