ormer Cabinet Minister Alfred Sears says unless The Progressive Liberal Party undertakes fundamental internal transformation, "it is unlikely that the party will regain anytime soon the loyalty of its disaffected members and win the trust of the wider Bahamian electorate."

Mr. Sears who ran for the position of leader of the PLP before said he was asked by many of the Party's stalwart Councillors and delegates to contest for the leadership position in convention currently progress. He said while he is grateful for the expressions of confidence in his leadership, his experience as a candidate for leader in January 2017, as confirmed by the results of the general elections in May 2017, convinced him of "the urgent necessity for the PLP to reconnect to its core values and institute radical internal governance reforms to create a more democratic, transparent and accountable

Mr. Sears represented the people of Fort Charlotte for two consecutive terms in the House of Assembly and served as Minister of Education and Attorney general in the first Christie administration in 2002.

He said, "the Constitution of the PLP mandates that there be a National General Convention every year in the month of either October or November or as is otherwise determined by the NGC. The Convention this week will be only the second time, in about eight years, that the Branches, NGC members, Delegates and members of the Party will assemble in national convention to review the work of the Party, modify and/or establish new policies, programs and Standing Orders, make amendments by resolution to the Platform, Byelaws and Constitution, receive and adopt reports of the NGC and Branches and elect Officers of the Party."

#### Wiclhombe Says Christie Thinks He Would Be A "Good Fit" For Chairman

While former Progressive Liberal Party leader Perry Christie has not publicly stated who he will support for leader or chairman, former Tourism Minster Obie Wilchcombe has indicated that Mr. Christie has said that he would be a good fit for the position he is seeking.

Mr. Wilchombe made the revelation while appearing as a guest on the Love 97/ JCN Program "Jones and Company.

"He has indicated that he thinks I would be a good fit for the chairmanship of the party, I've worked with him, I've been loyal to him and his leadership because I believe that's imperative for an organiza-

"I believe Christie has been misunderstood in many circumstances, I think often times he has been wrongly criticized," Wilchcombe said.

Mr. Wilchombe also stated that he does not believe in the antagonistic campaign and "attacking his brothers" and believes that he should be elected chairman based on his ideas, thoughts and relationships and these factors must be in

the best interest of the party. Mr. Wilchombe added that he agrees with pundits call for the party to rebrand, as he has been a leading voice for this new transformation of the PLP since its crushing defeat at the polls in May.

Mr. Roberts, the PLP outgoing chairman focused on the fact that crime has seemingly increased under the current administration, saying, "Crime unemployment and has increased and the consensus is, the FNM has no plan for our Bahama land."

He then accuses Prime Minister Dr Hubert Minnis of being in denial, as to the disappointments that plague the Bahamas.

"Dr. Minnis remains in denial as he continues to tell Bahamians that there is a sense of calm over the country, while eight month old babies and teenagers are being murdered on our streets and in the safety of their homes.

"Clearly this calm was the calm before the fury Category five hurricanes FNM hit the Bahamas." Mr. Roberts shared with the audience.

It has been five months since the FNM assumed office and Mr. Roberts indicated that although five months ago the PLP faced a devastating defeat by the Free National Movement (FNM) at the May 10th polls, where the Bahamian people spoke loud and clear, he reassured persons that "this is not unchartered political waters".

He told PLP delegates that just as this most recent loss was heartbroken for many, the former administration has found ways to overcome such defeats in the past and is confident they will

succeed again in the next general election; he said,

"We made this journey between 1992, 1997 and 2002 with glorious electoral results, so be not dismayed. We will bounce back once again."

For only the third time in the party's 64 year history has there been a change of leadership. As the PLP undergoes a leadership transition, Mr. Roberts says "this tells me that the Progressive Liberal Party delegates take the awesome task and responsibility of choosing their leader very seriously.

"We understand that our election positions have implications, not only for the future of our party, but the policy direction of our country, "he said.

The 53rd National General

Convention's theme is 'A new perspective is timely and appropriate' and Mr. Roberts believes that the exchange of ideas and policy proposals would reflect the national day mood of the Bahamian people.

Additionally, Mr. Roberts also implored persons to be tolerant of opposing views during this general election. He said, "As you campaign for and debate the merits of the various candidates of your choice, I beseech you, not once, not twice, but one hundred times to do so in a spirit of mutual respect.

"Please be tolerant of opposing views and voices of descent and these expressions are part and parcel of the democratic process and fully protected by the party's constitution," said

Mr. Roberts.

He then disclosed that amendments have been made to the PLP's constitution, based on the report of the standing constitutional committee dated 16th of October.

The report to Mr. Roberts (the former PLP chairman) says, "The party will be guided by the new leadership going forward on our proposed major review of our party's constitution."

He said, "when we emerge from this convention, I'm confident we will be stronger and more united as a body politic and to return the great Progressive Liberal Party to the governance of this country as we fight for the soul of this great commonwealth."

Amid public outcry in the aftermath of the government's immigration ultimatum, Prime Minister Dr. Hubert Minnis announced over the weekend that his government will establish an independent Commission to approve citizenship applications. Since independence citizenship applications were approved by the Cabinet.

However, while appearing as a guest on the Love 97 Radio Program Mr. Mitchell said the issue isn't as straight forward as it seems and may require adjustment to the law to make it a reality.

"The question is we would have to see the legislation the devil is in the details; can the government derogate from the power the constitution gives to the government.

"A delegate can't delegate, the constitution gives you the power, at the moment is says the minister and the minister is the conduit is the cabinet.

"My view is that you can have a committee of the cabinet but the minister should just be the min-

"I want to look very carefully at what the legislation may say because as I read it now the constitution does say parliament by law prescribes how citizenship can be granted, it does not allow as far as I can tell you to delegate it to some other body.

"It was always envisioned to be a decision of the government, now the government in my view can mean the minister, the cabinet committee but it should always be subject to the political authority.," Mr. Mitchell said.



### BISHOP HALL CALLS For Government Intervention In Policies

Eight years since the CLICO debacle, Bishop Simeon Hall is calling on the government to step in to ensure that Bahamians are protected from eventualities like the one that led to CLICO flatling.

With yesterday being the second tranche of payments in a series of three tranches during 2017, policyholders gathered at the CLICO head office on Mt. Royal Avenue to collect their cheques.

Speaking with the Journal, Bishop Hall, who was once a policyholder with CLICO, commended the government for living up to its commitment. However, he called on the government to ensure that another episode of failed insurances does not reoc-

"CLICO has made this another expression of its obligation to the policyholders and we are very glad and we commend the government for continuing to bring this to fruition.

"I cannot resist the temptation though, to call on the government to see that this never happens

"And that all those policyholders are dealt with as soon as possible," he

Bishop Hall says that although he and many of the policyholders are grateful that they are being paid out, he wished

that the government had met with individuals who held policies with the company.

"I would have liked for a government official to call people together and to give them information. But be that as it may people are hurting by this," he said.

Bishop Hall recounted how, although, one man was receiving a cheque, he was overwhelmed by the timing of which the checque came.

"I met a gentleman sitting at a desk and he was crying, literally crying and I asked him, sir what's the matter, you're getting a cheque why are you crying?

"He said I wish my wife was here to enjoy this day. She died two years ago waiting for these kinds of things. So, you know some things are just egregious and wrong and CLICO is one of them.

"But again, thank God for small blessings and I hope that the day comes soon when this thing will be finalized," Bishop Hall said.

He expressed concern that the monies from CLICO had allegedly been invested and that investment did not pan out when the company closed its doors and added that policyholders were left 'holding the

"I often wonder who is the Minister of Finance

when CLICO went belly up. Who were those who were able to get their monies out one or two weeks before the debacle; some things are just wrong, and this is one of them.

"I can't say specifically, but it seems like some monies went elsewhere and was invested and the investment turned sour and thus we were made to stand with the empty bag, holding the bag.

"The money never should have left the Bahamas in the first place. You could only take certain amount out; so how come? Somebody fell asleep at the wheel while CLICO went belly

up," Bishop Hall said.

CLICO payouts took place for New Providence policyholders yesterday and will continue for Grand Bahamians on Monday October 30.

According to a CLICO (Bahamas) Limited (in Liquidation) Notice qualified policyholders, with few exceptions, were expected to receive up to \$5,000 in respect to their outstanding claim balances.

Policyholders have yet to collect their cheques from the tranches that took place in April of this year and of last year will receive combined payment covering those disbursements.



## "WHERE IS MR. NYGARD'S SWIFT JUSTICE" to rebuild his house?

Environmental Activist, Vivian Whylly while being interviewed on JCN's The Platform television show, opined that fashion mogul Peter Nygard has been denied justice because at four years he has yet to have been given permission to rebuild his home on Nygard Cay.

Mr. Whylly expressed that The Government of The Bahamas needs to grant Mr. Nygard a permit and allow him to rebuild his

When asked by the show's host, "Wouldn't the

Government be in contempt of court since this matter is under judicial review?" Mr. Whylly responded, "A lady in Old Fort Bay was charged and convicted with killing her husband, and sentenced in a shorter time than it takes the Government to make a decision on Nygard.

"You have to be able to reasonably expect due process to be done in a timely manner. It's been 4 years of wasting time."

Mr. Whylly also expressed the view that the public doesn't know a lot about the injunction, and that they are simply aware that there is an ongoing feud between two neighbours.

Save The Bays has taken the Government of The Bahamas to court for a judicial review concerning the decision to issue permits to Mr. Nygard to rebuild his home after it was mysteriously burned down a number of years ago. Mr. Nygard is still waiting to be granted permission to rebuild.

About the Bahamian people, Whylly states: "All they know is a feud. That's how bad this is—the newspaper ads and all the rest of that have nothing to do with the court moving on the case."

Mr. Whylly feels that the court can deal with any contempt of court matters while at the same time dealing with the substance of the case on the injunction.

He went on to use this analogy: "If you pay your light bill and they turn your light off, they breach the contract. Peter [Nygard] pays his taxes. Make a decision. That's all the Government should concentrate on and do.

"Where's Mr. Nygard's Swift Justice?" Whylly asks.

This is precisely why we insist that: It is unfortunate that Mr. Craig Flowers and some others in the gaming business are now being pressed to answer charges that what they do can make addicts of some of their clients.

Strangely enough and therefore also with of large degree of paradox attached: Practically no one seems prepared to levy the same type of charge against the merchants who make a lion's share of their fortunes from the sale of whiskey, gin, win, et cetera and even more alcohol that cam come under that very useful et cetera!

This is so very curious.

If the truth be told: Vast fortunes have been made off the import, transport and consumption of Scotch Whiskey and other such libations to a Prohibition-Dry United States of America; and of course, practically every one favored enough to work in a suite - as opposed - to doing so on any of our dustymean streets can attest - Happy Hour does not come quick enough for so very many of

Sad to say: Very many of them become addicted!

What continues to amaze, therefore has to do with the extent to which Alcoholism is ignored whilst practically every ninny and her uncle can and do so brazenly excoriate the men and the women who have gone bigtime whilst offering a 'magic-driven' opportunity to win [obviously with the odds stacked against them] - and so do they entertain themselves.

### Bahamians Want One for One in Our own **GB Power Company!**

The hostile Takeover of Grand Bahama Power Company by a 100% foreign owned company, (Emera) which The Free National Movement Government approved without consultation with Bahamian shareholders of ICDU and without reference to any public policy conversation with general Bahamian public about foreign Company owning Power generation plant is wrong. More specifically, they did not consult with land owners, residents and licensees of the Grand Bahama Port Authority in Grand Bahama, the people most affected by its impact under Hawksbill Creek Agreement and primary obligations of GBPA to provide and maintain Utilities.

This is the Peoples' Power Company; The FNM is Selling the People Out

Currently, the Bahamian shareholders in ICDU own something which initially generated dividends at 10 % pa for many years.

If the FNM government allows this transaction to after through, go November 8, 2017 Bahamians will own noth-

Why doesn't Emera simply trade us one share of GB Power for 1 share of ICDU?

This is how Emera operates in the Eastern Caribbean, where the people of each country directly own shares in the Emera power company operators, and those shares are traded on the Eastern Caribbean Stock Exchange.

So why not repeat the same formula in the Bahamas?

If this transaction goes through, Bahamians will own nothing; we will own no shares in any company only depository receipts (DRs) and we may or may not get dividends in the future.

Our rights will be governed by the Toronto Stock Exchange.

profitable subsidiary of all of Emera's galaxy of Canadian and international companies.

We will be deprived of receiving profits from our

We will only get, maybe some dividends from Emera which averages out all profits and losses from its corporate galaxy.

- Shareholders of ICDU are frustrated because we have not been getting dividends for years.
- Freeport is hurting and Shareholders of ICDU will be motivated to sell because they need money and haven't even been able to get dividends.
- By not paying dividends, the value of the ICDU shares on BISX has been intentionally depressed over the years; compare the increase in value of shares over the same years in eg Emera in Canada or other energy companies.
- Thus allowing KPMG to "value" shares low!
- And once Emera owns 100%, rates in GB will increase and residents and businesses of Freeport and GB will pay for all the increased value of electricity plant growth investments etc without reaping any of the benefits, i.e. Bahamians will pay for infrastructure growth for Foreign capital gains and benefit, with a small return, after losses of all other locations taken in to the equation
- Note how cautioned all of the contents of their original email are about profits from DR in future.
- The approved transaction is complicated and convoluted and not in the national interest of the Bahamas and especially the residents and business in Grand Bahama.

Currently if GB Power makes profits, Bahamian shareholders and regulators will see those on the books and can go to a shareholders meeting and can be consulted and can speak and can agitate locally and politically and can make a local difference.

Once our shares are converted into international depository receipts, we become corporately and completely politically impotent in respect of our own local power company.

This is social, political, economic and cultural suicide.

We are giving up our sovereignty over our power generation in the industrial capital of the Bahamas!

Let me try and simplify it even further:

Right now, Bahamians



especially the residents of Freeport invested in their future nearly 20 years ago, actually own and are entitled to accountability from GB Power that runs the local power station.

If this transaction goes through, Bahamians will now own nothing other than a big promise of possible dividends from a foreign entity unrelated to GB Power with no accountability.

There may never be dividends; there is no longer any transparency of the financial value of GB Power: the profits of GB Power never have to be shared; it will no longer be listed in the Bahamian stock exchange.

It's a complete rip-off

Even if Emera is 80% owner of GB Power (which it is not)

What is the government of the Bahamas doing secretly approving transactions in which the owners of the shares haven't even been consulted about an arrangement between the government and Emera

In which they are going to forcibly take the shares owned by Bahamian citi-

The whole object of the original sale was for GBPA to remain in control of GB Power.

The construct was always that the board of directors of GB Power would be equally appointed by GBPA/ICDU.

And also because of the Hawksbill Agreement that GBPA would have management control of GB Power.

This is how it operated until Edward St George's death and a few years after.

When the Saint Georges sold their 25% of ICDU; then the Haywards sold 25% of ICDU, that left 50% of the Bahamian owners.

And of course Emera has proceeded to acquire

bit by bit more of the Bahamian shares.

But it was always the premise that Bahamian power company was owned by a Bahamian company which had management control of GB Power through ICDU and GBPA under terms of HCA.

And also that Bahamians especially residents of Freeport would be able to benefit from profits generated from the local power company (not averaged profits and losses for all of Emera's activities all over the world)

So to create a construct in which Bahamians and residents no longer have any direct or indirect ownership and GB Power; and

GB Power is no longer under control of GBPA on its obligations under the Hawksbill Creek Agreement et cetera; and

What they're doing is putting Bahamians into nonshare ownership of some international entity or Caribbean entity which may never give dividends on the depository receipts, and has no accountability to the securities commission, or any kind of financial scrutiny by the Bahamas government to look after the interests of Bahamian shareholders,

St Until Edward George's death, all Bahamian shareholders in ICDU received 10% on their investment.

Dividends were always 10% of the value of the investment until just a couple of years after Edward died.

So, by converting the ownership from shares directly or indirectly in GB Power,

GB Power can be delisted from the BISX and will no longer have to file any financial statements;

And because GBPA doesn't have any interest in it any more through St George and Hayward they are basically going to let GB Power rape the community on rates

This is exactly what happened when Hutcheson and GBPA negotiated a 20 year extension of all of the tax provisions under the HCA under the PLP in 2015, but, all other licenses had to pay real property tax et cetera unless they came

to some kind of agreement with the government under GB incentives act.

Basically the Hayward and St George families which own 50% of the GBPA have once again sold GBPA licensees and residents out and our PLP and FNM governments who have secretly approved this from early this year have been complicit in selling "The People " out!

GB Power is the most profitable centre for all of Emera International and Caribbean affiliate.

They make a huge prof-

And now by converting the shares of ICDU into

Depository Receipts in some other affiliate of the Caribbean, whatever dividends or returns might come along are dependent upon the profits averaged from all the companies as opposed to Bahamian residents who previously owned shares in directly of GB Power through I see the utilities of the local power compa-

What they're doing is further capitalizing on the profits of GB power.

Whereas until this arrangement, because profits and dividends to ICDU shareholders were directly related to the profits generated from GB Power in Grand Bahama they would generally receive dividends.

Now, by removing GB Power from the formula. the residents and owners of shares in ICDU that convert their shares into depository receipts of the international or Caribbean Emera may never get any profits and

What profits we may get do get by way of dividends are not directly related to GB Power.

It's just another way of making more money from Grand Bahama.

It's just a big rip-off.

The government is too blind to see that.

The simplest and most honest process is for Emera to offer to buy out anybody who wants to sell at whatever price they want of the shares in ICDU.

But whoever wants to keep their shares should be able to swap it equally for a share in GB Power.

He told the seniors that it was their duty to make


certain that the generation of the future has a foundation laid for them.
