In his remarks Prime Minister Minnis told Sir Arthur, "You have given your lifeblood and every measure of devotion for our country. We revere and love you."

According to the Prime Minister, it would take the poetic genius of Caribbean Nobel Prize winner Derek Walcott, or the brilliance of the West Indian Renaissance man Rex Nettleford, or the artistry of Max Taylor and Brent Malone, or the words and imagination of Sir Arthur Foulkes "to even begin to express the tremendous gratitude of the Bahamian people for the life and the legacy of the national hero, whose ninetieth birthday we joyously celebrate this evening.'

"He has the right to act when he deems appropriate, but in that decision making process, he has to take into account the conventions of the Constitution that relate to that duty and the role that flows from that duty to be exercised and the importance of it," Mr. Davis said.

Mr. Davis further added that he will not support the appointment of anyone to the post of Chief Justice, particularly one that would be appointed "directly from the 'Boiler Room' of politics".

In fact, the opposition leader said that he has repeat-

edly raised concerns over the matter, explaining that the existence and effectiveness of the Judiciary rests primarily in the confidence the Bahamian public have placed in it.

The Member of Parliament for Cat Island, Rum Cay and San Salvador said he is waiting on consultation for the appointment as the government must get on with it.

In December last year, Prime Minister Dr. Hubert Minnis appointed Justice Stephen Isaacs as acting chief justice sparking concerns among senior lawyers that he has undermined the independence of the judiciary.

Chairman Bahamas Agricultural Health and Food Safety Authority Mark Humes, and the Department's Officer-In-Charge Josefina Curry, attended the 13th session of the commission on phytosanitary measures or CPM last month in Italy.

The meeting of the CPM, the governing body of the International Plant Protection Convention (IPPC), reviews the state of plant protection around the world, identifies action to control the spread of pests into new areas.

They also develop and adopt international standards - establishes rules and procedures for resolving disputes, adopts guidelines for the recognition of regional plant protection organizations; and

cooperates with international organizations on matters covered by the Convention.

During the five days of discussion, the delegation participated in a wide-range of topics on issues related to local and global plant health, plant protection issues.

Topics covered at the meeting included Plant Health and Trade Facilitation, Plant Health and Environment Protection, Human and Plant Health Interaction, ePhyto certification, e-Commerce, Sea Container Cleanliness, and Cooperation between Standard Setting and Standards Implementation.

In addition, issues that have an impact on countries like The Bahamas who depend on trading large quantities of plant and plant

products, like grain, fruit, vegetables or timber to sustain their economies.

They also held strategic planning meeting with regional and international plant health officials to discuss The Bahamas' phytosanitary capacity development plan.

As a contracting member of the Commission, the Bahamas, in partnership with other CPM contracting nations, is responsible for implementing the work program of standards development, information exchange, and capacity building.

#### **AMERICAN AIRLINES ADDS FIVE NEW FLIGHTS TO THE BAHAMAS**

American Airlines, the largest international carrier to operate service to The Islands of The Bahamas, has added five new flights and 453 total seats, increasing the number of nonstop and connecting flights from three, major U.S.

Beginning in December 2018, the new flights will offer more nonstop options and enhanced connectivity to the islands-nation's capital city of Nassau and some of its most beloved family islands - Grand Bahama Island, North Eleuthera and Abaco – for travelers escaping from the Chicago, Miami and Charlotte gateways during the cold winter months.

Nonstop flights from O'Hare International Airport (ORD) in Chicago to Lynden Pindling International Airport (NAS) in Nassau will begin December 22, 2018, operated by a B737-800 aircraft. The new service will add 160 seats each week from the major Midwest hub.


Seasonal flights from Miami International Airport (MIA) to Freeport, Grand Bahama (FPO) will launch on December 18, 2018, operated by the E175, a 76 seat aircraft. The two morning departures will transport Miamiarea travelers to paradise in less than one hour, with the first flight departing Miami at 9:02 a.m. and arriving in Freeport at 9:50 a.m. and the second departing at 10:32 a.m. and arriving at 11:20 a.m. Both weekly flights add 152 seats to Freeport, bringing valuable support to the

The airline will also launch year-round service from Charlotte Douglas International Airport (CLT) in North Carolina to two destinations in The Bahamas. Saturday service into North Eleuthera Airport (ELH) will begin on December 22, 2018, adding 65 seats on the CRJ aircraft. A second Saturday-only service will introduce 76 new seats into Marsh Harbour Airport in Abaco (MHH), operated by the E175 aircraft. The weekly flights will bring a

total of 141 new seats to The Bahamas. Bahamas Minister of Tourism and Aviation Dionisio D'Aguilar is confident that the new flights will help fill the higher inventory of rooms added by new hotel developments throughout the Islands of The Bahamas.

The new air service contributes to a very encouraging trend in air arrivals to The Bahamas recently reported by the Nassau Airport Development company. Arrivals have reached the highest level in 11 years, exceeding even prerecession numbers. More than 150,000 visitors landed at LPIA in December 2017, and preliminary results for March 2018 are even more impressive – up by 24 per cent over 2017 arrivals.

"The addition of several new flight options from American Airlines is welcomed news for the local tourism industry," said D'Aguilar. "As our room inventory increases, we are eager for to meet that demand with more seats bringing travelers to our islands. The benefits will be felt especially during our winter months when tourists from cold areas are looking for a warm, sunny vacation," said the Minister.

#### Recall Of Eggs

The Department of Agriculture is advising the public on the voluntary recall of eggs produced by Rose Acre Farms Hyde Country Farm.

The Bahamas has been determined by The United States Food and Drug Agency (FDA) as one of the international locations the recalled eggs were distributed.

These eggs sold under multiple brand names include Coburn Farms, Country Daybreak, Food Lion, Glenview, Great Value, Nelms, Sunshine Farms, Publix and Sunups.

The department says the viral image posted on social media purporting that contaminated eggs were being sold by a local retailer.

The department wishes to advise the public that inspectors have reviewed the batch information on the cartons on the shelves and have determined that they are not from the original recall list.

Consumers and retailers should check carton or packing of their eggs for the following:

Plant number P-1065, lot code or Julian date between 011-102, plant number P-1359D, Julian date 048A or 049A, best by dates April 02 and April 03.

Plant numbers and Julian dates are printed on individual boxes, with the Julian date following the plant number for example P-1359D- 048A.

Consumers should not eat any shell eggs from the lots listed and if you have any of the above products you are advised to discard the product or return to their place of pur-

The department also advises to practice safe food handling and preparation measures

# EU To Implements GDR In The Bahamas

On May 25th, 2018, the European Union (EU) will implement its General Data Protection Regulation (GDPR) in all member states

While the new regulations will directly impact EU countries, implementation could also affect Bahamas-based organizations conducting business with entities falling under the arc of the regulations.

Sunryse Information Management, a data management firm based in Nassau, says local companies failing to comply with specific data collection guidelines as outlined in the GDPR regulations while engaging with EU companies could be subject to face stiff fines of up to €20 million or 4 per cent of their annual revenue.

President of Sunryse Information Management Chris Sawyer said, "How companies collect, store and eventually destroy data from agencies or organizations in the EU member states will be further scrutinized once the new GDPR regulations come into effect this month.

"Businesses in The Bahamas must look at their overall process and have a handle on what personal information is being gathered from clients be that names, emails addresses, credit card details, banking information, insurance details or any other personal details specific to that individual.

"There also has to be a clear understanding of the chain of command as the data moves from the customer through various channels within your organization. Once collected, it is also important to determine how a company manages the information now in its possession. Careful consideration should be given to obtaining consent from clients when passing client data between entities."

Sawyer started Sunryse Information Management 18 years ago with the goal of helping companies properly dispose of confidential information through shredding Since then, the data management company has expanded services to include secure storage of physical client files and also digitizing client documents for clients seeking to store and manage information digitally.

For organizations in The Bahamas, conducting business with EU clients or customers where there is any exchange of goods or services or if the company is monitoring the behavior of persons based in the EU, the responsibility of compliance ultimately rest with the organization gathering the information.

The Sunryse team continues to work with its clients to ensure compliance by the GDPR implementation date and offers the following tips to local businesses impacted by the new regulations.

The first step towards determining compliance is to become knowledgeable about the new regulations. Next, Sunryse urges its own clients to evaluate their current data collection and retention policies.

Under the new regulations, individuals have the right to access and review their personal data. The company collecting the information must correct all inaccuracies and erase any information that an individual request to be removed or redacted.

Individuals can also object to being solicited through direct marketing based on information collected and have the right to move data collected to another entity.

With this in mind, local companies impacted by the new GDPR regulations must determine how they will organize and store information in a way where it is secure and can be easily provided upon the request of a client or a consumer.

Sunryse encourages companies to put a comprehensive plan in place to manage data throughout its complete lifecycle—from collection, retention and destruction of records on client request.

#### **MINISTRY OFFERS CLARITY ON FLY-FISHING**

After much controversy over fly-fishing activities, The Ministry of Agriculture and Marine Resources is seeking to bring clarity to the ongoing public discussions concerning the Fisheries Resources (Jurisdiction and Conservation) (Flats Fishing) Regulations, 2017.

As a matter of history, the government of 2007 – 2012, sought to accelerate the sustainable development of the fly-fishing industry.

Having considered the economic impact and the fact that it is a niche market where Bahamians can take ownership and develop a sense of economic empower-

ment within their communities, the decision was then taken to draft enabling regulations, preserving the indus-

try primarily for Bahamians. It was then agreed, among other things, that only Bahamian citizens should be permitted to be licensed as guides and authorised to offer guiding service for the fly-fishing industry; and that visiting anglers engaged in fly-fishing activities be required to use the services of a licensed guide.

The General Elections of 2012 overtook the plans of that administration; however, the incoming Government followed through with the standing legislative prescriptions for the most part.

The significance of the

flats fishing industry is fully appreciated by this Government.

The Government recognises that the stability of our economy depends on the strength of its middle class and small and medium-sized businesses.

The Ministry of Agriculture has resolved to empower a new class of entrepreneurs and that includes practitioners in the fishing industry.

The Minister, Renward Wells said, "as a consequence, I am happy to reiterate the continuance of the Flats Fishing Regulations, 2017, and I look forward to the input and continued support of stakeholders as we move this process forward."



### New Flights Roundtrip Flights From Miami To Bimini

Two Haitian males were apprehended in the Southern Bahamas on Friday by members of The Royal Bahamas Defense Force after they failed to produce legal documents.

While on routine patrol, the HMBS Kamalamee, under the command of Senior Lieutenant Valentino Rolle stopped and boarded a 45-foot Haitian sail sloop.

The vessel was approximately 6 nautical miles off the west coast of Great Inagua.

Investigations conducted by the Boarding team revealed a total of five Haitian Nationals were on board. Two of the passengers did not produce the necessary documents to enter the country. Both passengers along with the Captain of the sloop were subsequently taken into custody and handed over to police and immigration officials in Inagua for further processing.



# We Became an Inward Looking People Part 1: Bahamians as Global Traders

Until the end of World War 11, The Bahamas looked outside. It was a British colony in the Caribbean that was very different from the others. Even though its economy was agriculturally based, its food production system was not one of a plantocracy dominated by sugarcane estates with slave labour. It was one orientated to supplying the global market with exotic commodities.

Export agriculture for the Caribbean was centred around sugarcane production. The Bahamas, on the other hand, developed a global market for a range of agricultural and marine products. Its proximity to the American and Canadian markets enabled The Bahamas to have a unique access.

From 1900, The Bahamas was exporting agricultural commodities -citrus, pineapples, tomatoes, okra(supplied Campbell Tomato Soup of Canada), onions and sisal(Neville Chamberlain, former British Prime Minister operated a sisal farm on Andros for six years) to the US and Canadian markets and Cascarilla Bark to Europe. In conjuction with agricultural exports, The Bahamas was a major source of marine products for the export marketsalt, sponges(Queen Victoria's sponge of preference was the velvet variety from The Bahamas. The sponge was the commodity that attracted the Greeks to this archipelago.By 1938, the sponge industry had collapsed as a result of a disease which put thousands of spongers out of work.), turtles and turtle jewellery items, ambergris(byproduct of the sperm whale) and lobster.

Throughout the 20th century, agricultural exports played a significant role in the economy ,particularly on Andros and Abaco, where US Off-Shore growers and companies were supplying the eastern seaboard of America with a range of winter vegetables(squash, cucumbers, okra, tomatoes and sweet peppers), citrus (oranges, limes, lemons and grapefruits as The Bahamas had the third largest acreage in CARICOM) and avocado pears as well as pineapples. Hundreds of Bahamians, particularly women, were employed as farmer labourers, farm machinery operators and mechanics, irrigation repair and maintenance personnel, export grading and record keeping.

With reference to marine products/ commodities, lobster exports have evolved into 100 million dollar industry along with Aragonite, a multi-million dollar business.

Trade in the export of agricultural and marine products has been an important aspect of our economy. At the domestic scene, the Produce Exchange and the network of packinghouses on the Family Islands generated incomes and employment opportunities for farmers and their families

The Bahamas had a long history of trading with its closest neighbours-the US,



Canada, Haiti and Cuba. The basis of the wealth of the Bahamian oligarchy, the Bay Street Boys, stemmed from the monopolies they were able to created as Commission Agents for American, Canadian and British products. Agency for various products became synonymous with certain families. Imports became an import part of the Bahamian economy as it generated wealth not only for the oligarchy but also for the State. The main source of revenue was excise duties.

Haitian products had a presence on the Bahamian market via Mr Wilfred Toothe, the brother of the Hon. T.A. Toothe, who had a Haitian Emporium on Woodes Rodgers Drive or ,as it was called, the Market Wharf in those days. Mr Toothe travelled to Haiti buying all sorts of Haitian products as Haitian vessels anchored on the Wharf and off loaded fruits, rum, wood carvings, paintings etc. The Haitian sloops went back to Haiti with various products.

The Bahamas was also market for Cuban products. The chief agents for Cuban products were Ragged Islanders who plied between Duncan Town and mainland Cuba, only 139 miles away. Cuban products were brought to Nassau and sold on the Market Wharf from the Ragged Islands vessels. Trading with Cuba was an important part of the Ragged Island economy.

Inagua was unique as it traded with both Haitians and Cubans. Many of the residents were tri-lingual. Matthew Town to mainland Cuba is less than 90 miles and Port de Paix, Haiti is only about 70 miles. The trade dynamics in the Southeastern Bahamas included Haiti and Cuba, so there was a familiarity with people and places.

For economic survival purposes, Bahamians had to look outside. During the days when the Panama Canal was being built, scores of young Bahamian men caught ships leaving places like Long Cay for Panama in the early 1900s.

An amendment to the bill was later proposed with a new version now giving that authority to the Attorney General.

In light of these moves by the government, the PLP leader expressed his dissatisfaction because he believes the amendment places another 'political appointee' with the power to authorize interceptions.

Mr. Davis also said that

during the PLP's term in office, the Privy Council strongly advised the government to modernize its law and in the process to remove the jurisdiction from the political directorate to the jurisdiction of the court to give permission for interceptions as a way to eliminate the bias and prejudice from the process.

He added that when his government presented the bill prior to the last elections, it did so responding specifically to those issues that were nec-

essarv

This bill as it is being presented, he continued, flies in the face of the principle of having an independent public prosecutor so as to be free of political interference.

What is so amazing about the issue, he pointed out, is that some of the same people who opposed the bill when the FNM was the opposition party, are now supporting it. "What an about-face," he said. "Such a blatant act of hypocrisy."
