OUTRAGE OVER VAT

Party, I Chester Cooper says the government decision to raise Value Added Tax to 12 percent "is not only treacherous but is a reckless and dangerous move on the part of the government".

"The Government

shamelessly announced an increase in VAT from 7.5 per cent to 12 per cent. A whopping 60 per cent. This is an outrage.

"This is not economics. This is politriks and obeah economics.

"We put no faith in their fiscal deficit recovery strategy. One hurricane can come along and blow a hole in that strategy. It is pie in the sky.

"Imagine now how obtuse this government now seems, out of touch with reality.

"The banking system has failed Bahamians. The people in remote communities like South Andros and Acklins and Black Point have to depend on deposits in gaming houses to be able to get their money. Now it is going to cost them 5 per cent to put their own money on deposit. This is tax madness. It is unconscionable.

"Let me emphatically state that the PLP does

not support any increase in taxes in this budget exercise. We will vote against them!" said Mr. Cooper.

The shadow Minister of Finance opined that the proposals alone indicate the Minnis administration has no idea what it's doing.

Mr. Cooper added that when VAT was first implemented, experts including the Inter-American Development Bank, IMF, Standard and Poor's Moody's as well as Chamber of Commerce's consultants from Oxford, agreed that VAT should be implemented at 7.5 percent with no exemptions.

"What research has the government undertaken to determine that exemptions, despite the best advice from throughout the world, is the best course of action and not merely a political gimmick?

The 2018/2019 Budget Communication presented in the House of Assembly yesterday by Deputy Prime Minister and Minister of Finance, K. Peter Turnquest is causing political consternation around the Bahamas as Bahamians rebel against the government's decision to increase Value Added Tax (VAT) by 60 per cent. The rate has been moved from 7.5 per cent to 12 per cent.

Justifying the increase, Mr. Turnquest said, " our govern-

ment fully appreciates the sacrifice that the sub substantial increases in the VAT rate and other taxes will represent for our citizens. But as I have repeatedly said on record, this government was elected to do what is right for the welfare of the country and not to do what is politi-

cally expedient or politically popular."

In terms of fiscal performance, it was projected that the 2017/2018 GFS deficit will sit at \$310 million; an improvement of \$13 million.

Country's Bond Rating Is Junk, Says Minister

Making a startling announcement in the House of Assembly in a lengthy 2018/2019 Budget Communication yesterday, Deputy Prime Minister and Minister of Finance, K. Peter Turnquest said that "the country's bond rating is at junk status."

In defense of his government's decision to hike the VAT rate, he charged that the Minnis administration could do as those before and present a misleading budget with under-budgeted allocations and hidden obligations, and that it could have kicked the can down the road and borrowed some more – delaying the inevitable day of reckoning.

However, according to the minister, playing such a game would have only made a bad situation worse.

Baptist Leader Cites Crime As "The Worst of Times"

"For us today, crime and criminal activities ensure that we live in the worst of times."

These words were uttered by President of The Bahamas National Baptist Missionary and Education Convention, the Reverend Doctor William Thompson Tuesday night at he addressed the annual session.

He said that "crime stalks our land with tornadic destructiveness...

Families who can afford burglar bars and security cameras willing become prisoners in their homes.

"There has been an increase in the number of magistrates, judges and courts, new legislations are added in parliament regularly, but inspite all of this, the Bahamas is still in the grips of an epidemic of crime problems."

Dr. Thompson said a notion he has had for the past 25 years is for The Bahamas to collectively marshall our best minds to evaluate to analyze and to research specific questions as to the cause of crimes.

He commended the Minister of National Security and the Commodore as well as the officers of The Royal Bahamas Defense Force for all of their work in protecting our waters and combatting what he describes as a vexing problems.

He also said that any dent in crime is to be commended and saluted the authorities.

The Baptist leader said "we are saddened that the murder rates seems to be escalating once again, but what is sadder is that the assault of molestation of young children seems to be more prevalent."

"The truth is, it will make VAT collection more complex and potentially affect revenues beyond what the government expects it will miss out on from those exempted items.

"The FNM is undoing progress on the most progressive tax reform in generations without understanding what it is it is doing. "This is the same FNM that voted against VAT, claiming it would inflict pain and stress on the middle class and the poor, called it double taxation. In opposition, the now prime minister said it would remove the hope of a better life. Now there is move afoot to throw what has worked successfully out of balance," Mr. Cooper said.

Leader of the Opposition Philip Davis predicted on Sunday, in a press statement, that the government's 2018/2019 Budget would be a "bleak outcome and a recession inducing budget".

Mr. Davis during a press conference following the budget presentation, said that what was presented reaffirmed his belief.

"There is no doubt, and it is very scary. I share the view of my colleagues that the competence of this government has to be called into account. "I don't know who they are listening to, because clearly, I don't know if there is some textbook, academic approach to governance, but that they don't even seem to appreciate. But The Bahamas is a unique country, the fundaments of our economy are very much unlike many others because of our demographic and no doubt the expectations of our people.

"I fear they [FNM administra-

tion] don't understand the fundamentals of our economy; that's the first step in being able to chart a course for the lives of the people," Mr. Davis said.

Mr. Cooper added that the PLP will oppose these taxes and vigorously defend the Bahamian people against the FNM whose selfinterest and political survival have caused them to abandon any pretense of it being the 'people's time'.

If all goes as planned, capital expenditure will come in at \$153 million down from the initial forecast of \$230 million.

However, recurrent revenue is said to be less buoyant, and this despite the country's real growth rate.

According to Minister Turnquest, this is pegged to sit at some \$130 million below forecast – a yield that is well below others in the region and furthermore, inadequate to the government's needs.

Moving ahead, the government forecasted that the 2018/2019 recurrent expenditure will amount to \$2,589 million, an increase of \$346 million from the budgeted amount in 2017/2018.

According to the DPM the increase includes: \$172 million in arrears that will be paid in the coming year; the \$76 million increase as a result of the adoption of full and proper budgeting for known commitments across the breadth and scope of

government expenditures; some \$19 million for the new recurrent expenditure policy initiatives; and \$89 million for

additional interest payments. He also revealed that the level of capital expenditure in 2018/2019 is set at \$299 million, up \$69 million from \$230 million in 2017/2018.

The DPM added that the demands for new investments in public infrastructure exceeds the amount that is allocated for next year and the government does not want to prioritize such investments as a means of boosting potential economic growth.

He also mentioned that the outlook for recurrent revenue in the coming fiscal year is governed to a large extent by the fiscal impact of both the revenue measures proposed in the budget as well as the impact of the rise in the rate of VAT.

The lesser revenue measures – including adjustments up and down - are estimated to produce a net gain in revenue of some \$100 million while the VAT increase should net new rev-

enue to the tune of some \$400 million.

As a result, after factoring in the growth of the economy and targeted gains from enhanced revenue collections, total recurrent revenue in 2018/2019 is estimated at a level of \$2,649 million, or 20.1 per cent of GDP.

Minister Turnquest said that is an improvement in the revenue yield of 4 full percentage points from the level of 16.1 per cent posted in 2017/2018.

He added that while still lagging behind regional norms, such a level of the revenue yield is definitely more reasonable in relation to the needs of modern governance.

The GFS deficit in 2018/2019 is therefore projected at \$237 million, some \$73 million lower than in 2017/2018.

At 1.8 per cent of GDP, the deficit will come in at the target that will be mandated in the fiscal responsibility legislation.

According to the DPM, with the decline in the size of the deficit and the ongoing

growth of nominal GDP, the debt-to-GDP ratio is projected to fall to 56.1 per cent in 2018/2019, down from 57.2 per cent in 2017/2018.

In the outer years of 2019/2020 and 2020/2021, the growth of primary recurrent expenditure is being held to 2.5 per cent per year.

As such, this category of discretionary spending will decline from 16.8 per cent of GDP in 2018/2019 to 15.4 per cent of GDP in

2020/2021, the Minister noted.

Capital expenditure over the forecast horizon is projected to grow by 2.5 per cent per year.

Meanwhile, the projection for recurrent revenue beyond 2018/2019 assumes that the revenue yield of the tax system remains constant at its level of 20.1 per cent of GDP in 2018/2019 on the basis of these planning assumptions, the GFS

deficit in 2019/2020 is projected at \$85 million, or 0.6 per cent of GDP.

The minister said that in 2020/2021, a GFS surplus of some \$10 million is forecast, the government will readily achieve the deficit targets for those two years.

In addition, the debt-to-GDP ratio will decline steadily over the forecast period, to stand at 52.1 per cent at the end of 2020/2021.

Bahamian On Firearm charges

A 35-year-old father of two, Deolo Cordell Pratt was arraigned before Chief Magistrate Joyanne Ferguson- Pratt yesterday on three counts of the importation of ammunition and one count of conspiracy to import ammunition without possessing a fire arm certificate. The offences are alleged that have taken been committed between March and July 2016.

Pratt is a Bahamian citizen with American residency and according to his attorney was deported from the United States.

Pratt's attorney also said he resided in Jacksonville Florida for the past 17 years after marrying and attaining his green card. However he and his wife are currently separated.

Pratt pleaded not guilty to all counts and was remanded to the Bahamas Department of Corrections until august 8th.

me in, I needed clothes and you clothed me, I was sick and you looked after me, I was in prison and you came to visit me."


The Baptist community, he said, has a legacy of promoting the common good and social justice.

"The country's bond rating is at junk status," he said.

"The reason for that is because others before us failed to act promptly and judiciously.

"But worse than the junk status, the penalty for inaction is a continued quickening crawl toward a fiscal point of no return.

"And as we have seen, when countries hit crisis mode, the path to correction is extraordinarily hard and painful."

This blow to taxpayers comes as the government still has to pay off \$360 million in arrears, which it hopes to pay off in the next three years.

"With the implementation of this three-year fiscal strategy, the mandated deficit targets will be fully met in 2018/19 and the two following years," he

The government has committed that at the end of it, it'll return the favour so to speak to taxpayers.

"We make the commitment as well that, as the hundreds of millions of old arrears and obligations are finally paid off over the next three years, the government will then give back to consumers in the form of customs duty and excise tax reductions, on the order of \$100 million, to the benefit of Bahamians throughout the country," the DPM said.

No VAT On Breadbasket Items

Deputy Prime Minister and Minister of Finance, Peter Turnquest revealed during his presentation of the 2018/2019 Budget, that Value Added Tax (VAT) will be eliminated on breadbasket items, a "commitment to Bahamians".

"As for measures that that we are implementing to meet our commitments to Bahamians and provide tax relief to individuals and businesses: effective August 1, we are eliminating VAT on all breadbasket items, with the exception of sugar," Mr. Turnquest said.

With there being much talk about changing up breadbasket items, Mr. Turnquest listed several items that will no longer have VAT attached to it.

Items that VAT will be eliminated on include items such as butter, cooking oil, mayonnaise, grits, cheese, corned beef, margarine, rice, flour, bread, condensed

milk, soap, fresh milk, tomato paste, soup broths, mustard, and baby food.

"We are eliminating duties on a number of food products, including: whole salmon; frozen fish fillets; bread spreads; potato products; tofu; and prepared and preserved tomatoes," Mr. Turnquest said.

Mr. Turnquest added that VAT will also be eliminated from a number other items, including elimination of VAT on medicines and residential property insurance.

"We are eliminating duties on solar kits upon application to the Ministry of Finance," he said.

Further, the DPM said that VAT will be waived on residential electrical bills at or under \$100 and water bills at or under \$50

"For electricity customers, this would impact over 30,000 BPL households alone. For water customers, this would impact some 43,000 Water & Sewerage customers.

"This waiver will be applicable to all

licensed utilities in the country," Mr. Turnquest said.

Mr. Turnquest further revealed that customs exemptions will be increased from \$300 to \$500.

As foreshadowed, Immigration fees will increase as well as port, police record and fingerprinting fees for casino employees.

Labour certificate fees as well as real property tax on foreign owned vacant land will increase from 1.5 per cent to two per cent, while licensing fees on large commercial vehicles by \$50 for class b and class c vehicles.

The government is implementing various concessions in respect of Real property Tax, Customs duties, Excise duties, Business License fees and Stamp Tax in favour of designated Economic Empowerment Zones, beginning with the "over the hill community.

Mr. Turnquest said, "we are providing duty-free entry for goods for use in the commercial printing industry, as well as for processing and garment manufacturing equipment without the need to apply for specific concessions as before; we are extending for 5 years the firsttime homeowners Stamp tax exemption; we are extending for two years the duty exemption on materials used for the renovation, repair and upgrade of dilapidated buildings.

The Minister said, "we are reducing duties on floor tiles and fabric softener; we are extending the duty exemption to church buses 8 years old or less from the current limitation that limits the concession to buses that are 3 years old or less.

"We are providing an exemption from Business License fees for all schools that are registered with the Ministry of Education; and we are eliminating the duty on airplanes and helicopters in an effort to build an Airplane Registry Industry within the country," said Mr. Turnquest.

He said since coming to office in May 2017 he has a new vantage point to see, more in-depth, the challenges and problems as well as possibilities for the country.

Evans' uncle, Johnny Lee, said the young man had gone around the corner to return something to the shop for his aunt and to call his cousin because they were scheduled to go to a job where they decorate and set up for functions.

"We ain't taking this one easy," Johnny Lee said.

Police said one of the men pointed a gun at the officers.

The officers, being in fear for their lives, shot the armed man.

The man was taken to hospital where he died.

"We ain't stopping with this. This one going straight to justice. We going full ahead with this. If it takes our last dollar, we [will] spend our last dollar. We [are] going to spend our money. We [aren't] stopping with that."

EDITORIAL

LABOUR--THEN & NOW

In Sir Randol's words, "We knew that we were witnessing the birth of a new Bahamian working together with other Bahamians for a new Bahamas."

In Sir Clifford's words: "Little did I know on that Sunday morning in January 1958 that the stunning and unexpected aftermath of the general strike would pave the way for the turbulent decade of the sixties, ultimately leading to the freedom of majority rule for all Bahamians."

What we know for sure is this:---Once upon a time, great men did great things in The Bahamas; and for sure, amongst the greatest of things achieved by some of those men took place in 1958; with especial reference to the General Strike of that great year which was championed by Randol Fawkes, Lynden Pindling and Clifford Darling.

As we get set of celebrate another Labour Day, we feel constrained to suggest that: -- If we are to ever make The Bahamas the great little nation it might yet become, it is past urgent for the Bahamian people – especially its leaders – to be up and doing with seeing to it that, our youth are more fully aware of their country's fuller history; with especial reference to that long march – as it were – from Pompey to Pindling!

Evidently, it is this glorious past where struggle mixed and mingled through and through with aspiration gone to bed which –sadly-has been followed by what has become a very rough road for the labouring masses.

And thus, today, with nostalgia rife, some among us dream of the day when they might yet witness the emergence of the towering likes of Fawkes, Pindling and Darling!

Alas! That was Then---This is Now.

And thus on this auspicious occasion: — Let it also be known that becalmed as we are in these hard times, we are as lost as lost could be precisely because neither our churches or schools have been up to the challenge of preparing our youth for the challenges ahead; and thus today, we wallow in strife and far too many of us now suck on sorrows.

As Sir Randol records: -- "...At about 7am

January 13, 1958, Brother Pindling and I entered the Emerald Beach Hotel; rested our hands on the right shoulder of Saul Campbell, chief shop steward of the Hotel Workers Union and whispered, 'NOW!' This password re-echoed throughout the length and breadth of New Providence as our comrades performed similar ceremonies in other hotels."

This laying on of hands precipitated a general strike, one where:---Hundreds of hotel and electricity workers, garbage collectors, construction workers, longshoremen, civil servants, airline and restaurant staff walked off their jobs to the slogan "not a sweat".

As Fawkes concluded: -- Their action marked "the beginning of the end of British colonialism...white supremacy and racial discrimination."


Whilst it is true enough that this action marked the so-called beginning of the end to so much that was anathema in those long ago years, the fact remains that the workers' struggles for bread, for dignity and for respect continues.

But yet – and thus most regrettably: It is today painfully obvious to many already in the know why today's crop of leaders --especially those who would be guides to the working masses---are themselves bereft of any real or deep understanding of the key role the labour movement and its movers and shakers played in helping in the modern 'emancipation' of the Bahamian people.

Indeed, then, it is clear that: -- These three men [and the people they led] –united in common effort for the achievement of the common were immensely successful in making a quiet revolution in a then deeply expectant Bahamas!

Sadly, this unity did not last---and as fate would have it: -- Fawkes was the man who moved the 1970 motion of no confidence in Prime Minister Pindling that precipitated a major split in the PLP and led to the formation of the Free National Movement.

And thus it follows: That 1970 Fawkes action led not only to the ascendancy of Hubert A. Ingraham in 1992; but also to Hubert A. Minnis, today's leader of the Free National Movement and prime minister of the Commonwealth of The Bahamas.

PUBLIC TREASURY DEPARTMENT

The Treasurer of The Commonwealth of The Bahamas is conducting a new vendor verification exercise to prepare for an upgrade to its digital payment processing system on **June 15**. This will affect all individuals and businesses providing goods and services to the Government.

It is very important for all vendors to participate in this verification exercise so they do not experience any discontinuation of payments. Failure to participate in the vendor verification process will result in the discontinuation of payments.

Vendors must **submit or confirm banking information and email contact information** with the Public Treasury. This must be done by completing a Vendor Verification Form, available online (Go to www.bahamas.gov.bs, go to Forms top left click on vendor verification form and download).

For the past three years, the Public Treasury has been transitioning away from the use of cheque payments and other manual processes. This year, the Treasury plans to eliminate cheque payments all together. Payments will be made by direct deposit. And as of **July 1**, **all notifications of payments will be sent by email.** This will allow vendors to receive immediate notification when payments are sent to their accounts.


