# "Expect Higher Taxes"

#### • Davis paint grim picture

pposition leader Phillip Davis is warning the public to expect increased taxes in the new 2018/2019 budget of the Free National Movement government.

In a statement released yesterday, the opposition leader claimed that the

public can expect an increase in the VAT rate to offset the elimination of VAT on certain goods and services, an increase in selective customs, excise tariff rates, and real property taxes, the introduction of new and additional taxes, among other effects due to the "anemic" revenue growth over the past fiscal year.

# **DPM:** BUDGET TO SHOW FISCAL RESPONSIBILITY

Deputy Prime Minister and Minister of Finance Peter Turnquest says when he presents the national budget next week Wednesday, one thing you will not see in our budget is any runaway spending.

"We will spend the people's money responsibly, in accordance with our strategic priorities and the commitments made to the Bahamian people. All of our work at the Ministry of Finance moving forward will be conducted in the context of a statutory mandate to practice fiscal responsibility," he said.

Mr. Turnquest explained that the public can expect the government to make hard choices to lower the debt levels as well as make responsible choices to arrive at a more sustainable fiscal balance


Former Cabinet
Bradley Roberts sounded the alarm as he labels

This stems from recent and past construction projects across the nation in which the general contractor or initial construction company was relieved of their duties causing the tax paying public millions of dollars.

Mr. Roberts said that the most recent project causing concern stands on John F. Kennedy Drive, just west of the Paul Adderley Building.

He said, "It is clear that this public structure is substantially complete but work has suddenly stopped because I am advised the contractor, Lloyd Smith, has been fired. The general public and I have seen this scenario before with the construction of the Paul L. Adderley Building where incidentally Mr. Smith was the general contractor."

### Bahamas Off EU Blacklist

The Bahamas has been given formal notification that it has been removed from the blacklist of noncooperative tax jurisdictions or jurisdiction for tax purposes, but placed on a grey list, according to Deputy Prime Minister and Minister of Finance, Peter Turnquest.

#### Illegal Haitian Migrants Reach Venice Bay

A search is reportedly still on for illegal migrants after a Haitian sloop made landfall off Venice Bay, South New Providence

after midnight Saturday.
Several Law enforcement personnel including Royal Bahamas Police and Defence Force, as well as Immigration officers were

only able to capture 26 of the migrants who were on board and are now being held by Immigration offi-

According to reports, "shortly after midnight, a 35-ft a Haitian sloop made landfall off Venice Bay. Efforts by security forces resulted in the capture of 26 migrants, who were turned over to Immigration officials for further processing".

Defence Force is also reporting that prior to Sunday morning, marines were deployed to key areas along the coastlines of New Providence to support vessels patrolling off shore. However, much of the Defence Force's land base maritime and air operations have been hampered by adverse weather conditions.

Since May 2017, Defence Force officers have apprehended 13 migrant smuggling vessels and also apprehended or assisted with capturing over 1,000 migrants during the same period.

The Defence Force is also actively patrolling the waters for over fishing by American sports fishermen as well as mixed migrant smuggling in Grand Bahama, Bimini and Abaco. In addition to reports of Dominican poaching in the Southern

Bahamas.

The last landfall made by Haitian migrants on New Providence was in February of this year.

Defence Force personnel say they will hold a press conference today to speak to the latest incident and inform the public of solutions to challenges faced by the force.

Further, Mr Davis said, "the introduction of new and additional taxes to fund the deferred capital expenditure and assist in the ambitious deficit reduction target of the draft Fiscal Responsibility can be expected.

Mr Davis also projected no real increase in the recurrent allocation for any of the critical areas such as health, education and national security. He said the manpower and skills deficit in national security, health and education would continue to widen.

"A freeze on public service increments or a reduction of public service employment levels; Public sector salary increments automatically upwardly adjusted recurrent expenditure by about 1 percent per annum; Increments along with the increase in interest expenses principle amortization would likely breach the 3 percent rule," he said.

Mr Davis said reduction in subvention to public corporations would certainly mean job

The Member of Parliament for Cat Island, Run Cay, and San Salvador said that the Free National Movement (FNM) administration lacks a growth agenda to push the country forward.

He said, "In the first year in office, many of the gains made by the previous administration

have evaporated. For example, there has been anemic revenue growth notwithstanding the opening of Baha Mar. Revenue for the first 9 months is trending on par with actual revenue for the last fiscal year. This is disturbing as the last fiscal year's revenue yield was decimated by Hurricane Matthew."

Mr Davis said, "With the phased opening of Baha Mar and the absence of major storms impacting New Providence, revenue yields should have been at least 10 percent above the last fiscal year. A 5 percent increase in recurrent revenue would have allowed the Government to fully execute its capital budget."

On the expenditure side of

the budget, the opposition leader expressed concerns about the "widespread yet very selective terminations of contractual workers".

He said, "Expenditure levels have not dropped in comparison to last year. This is concerning, as vendors are not being paid on a timely basis to such an extent that arrears have risen to levels which is creating unsettling chatter among the business community about Government's solvency."

Mr. Davis also addressed the expectations of the public service.

He said that in critical areas like health, education, infrastructure, and national security need more resources and improved services on par with more developed countries.

He also spoke on the FNM's public policy promises which include eliminating VAT on a variety of goods and services, introducing economic empowerment zones in Providence, providing free tuition at the University of The Bahamas, increasing public private partnerships, and drafting a Fiscal Responsibility Act to keep recurrent expenditure growth less than 3 percent of the previous year's level and or less than the growth in nominal GDP.

He said that for a government without a real growth agenda, this is a bleak outcome and a recession inducing budget.

Minister of Finance pointed out the government's prioritized internal auditing as one of several initiatives showing how serious the government is about transparency, integrity and accountability. He spoke at a meeting of the Institute of Internal Auditors last Friday.

The Minister also said, "We

recognize that words like accountability and transparency must be more than political buzzwords. We must back that up by taking steps to ensure that we have a cadre of qualified financial and accounting professionals to enable the government to track and account for revenue and expenditure, and to uphold its commitments to fiscal responsibility."

Mr. Turnquest also said that fiscal discipline has not been a hallmark of all governments in the past.

He added, "at the governance level, the landmark fiscal responsibility legislation, released for public consultation two weeks ago, is a major initiative that demonstrates our seriousness and commitment to living according to this ethical standards and fiscal responsibility principles."

The government chose to develop the 2018/2019 budget in accordance with the law's guide-

Above all, Mr. Turnquest noted that the public will see the government embrace the idea of transparency and accountability " in a way no other government has done before."

# AIDS STATS REVEALED

The Ministry of Health has released its 2017 Global AIDS Monitoring Report. The 2016 Political Declaration on HIV/AIDS report reveals alarming statistics about HIV/AIDS in the country.

The comprehensive overview of the HIV/AIDS epidemic in The Bahamas showed that between 1985 and 2015, 13,449 persons were HIV positive.

According to reports, over a third of those cases or 35 per cent have since

died of AIDS.

At the end of 2015, 8,667 people were listed as living with HIV as determined through surveillance methods.

This means that roughly 1 in 50 persons in The Bahamas in 2015 was HIV positive.

In 2015, 226 persons were diagnosed with HIV in The Bahamas, which represented a 43 per cent decrease from the reported number of 396 in 2006.

Most of these cases or 84 per cent had not progressed to AIDS by the end of 2015.

New diagnoses in men exceeded the diagnoses in women, while persons aged 30-39, accounted for the largest age group of new diagnoses at 25 per cent.

Although new diagnoses have decreased among most demographic groups, cases among 15-24 year olds increased by 38 per cent between 2006 with 34 cases and 47 cases in 2015.

Cases among males in this age group tripled between 2006 with 11 cases and 27 cases in 2015.

Between 2006 and

2015, 1,155 persons died of AIDS-related causes in The Bahamas, with an average of 116 deaths per year.

The age-adjusted death rate decreased from 48 to 10 deaths per 100,000 persons in this time period

The majority of AIDS deaths in 2015 occurred

in persons born in The Bahamas at 84 per cent and 40-99-year old at 45 per cent.

He also said that during the FNM's last term in office between 2007 and 2012, the administration fired Mr. Smith.

He added, "In a very public account of the drama that unfolded, Mr. Smith withheld the balance of the building materials connected with the project. The case was taken to court where it was revealed that he was fired without cause, so he was paid the balance of the monies owed to him, he released the balance of the material, and the FNM hired another contractor to complete the project."

"The problem to the tax paying public was that upon completion, the cost of the building almost doubled, even though it was substantially completed. The initial cost was in the range of \$12 million. The waste on

this project was breath taking with no acceptable explanation coming from the FNM," he said.

In a statement issued yesterday, Mr. Roberts listed a number of projects in the country where the same issue transpired.

Some if these include a building

project in Mangrove Cay, Garvin Tynes Primary School repairs, the remand center in Fox Hill, and repairs made to Stephen Dillet Primary School.

Mr. Roberts invited Bahamians to

Mr. Roberts invited Bahamians to watch what he calls the "latest episode involving the new building project on JFK".

He also advised the public to watch for the government's explanation on the reasons for dismissing the current contractor, the initial project cost, and the completion cost after replacing the contractor.

DPM Turnquest, speaking with this Journal, said that the grey list is a list that includes "low tax jurisdiction or zero tax jurisdictions which the which the European Union has received commitments from to increase their transparency standards".

"That is just a transitory list that they have that they will monitor to ensure that we live up to the commitments that we made in respect to the timelines and the actual legislative and policy exchanges necessary in order to bring full compliance to the OECD criteria.

"We are certainly pleased to receive the news that we were moved off that first list as that was beginning to cause some concern within the international finance community.

"I want to particularly thank the hard working people from the ministry of finance, ministry of financial services and also the attorney general's office and as well as our partners at BFSB and AIBT as well as industry stakeholders who all worked very, very well in a collaborative manner and with great corporation and support to get us to the point where we are today," Mr. Turnquest

Mr. Turnquest however said that the work does not stop because of the delisting.

We now have to focus on the criteria with respect to economic substance and presence of these international entities in The Bahamas to meet the substance requirements test as well as to eliminate green fencing with respect to taxation and that's our next goal.

"We've already established the working committee that is dedicated to addressing this issue and we look forward to having policies and legislative proposals in short order in accordance with our published timetables," Mr. Turnquest said.

Contrary to speculation, Mr. Turnquest said that The Bahamas had to make no other commitments to the EU.


"The Bahamas has had to make no commitments on any other matter, other than the issues already outlined. There is no underhanded or under the table negotiation or agreements that The Bahamas has had to sign up to.


"The fact of the matter is that the European Union has not indicated or demanded any kind of concession from us in respect to the implementation of any kind of corporate task or personal income tax or anything of that nature; nor do they have the ability to do so as a sovereign nation.

"The fact of the matter is that we have agreed to live up to our commitment and our responsibility as a responsible international financial center to engage in a transparent tax exchange regime and we will live up to our commitments in that regard.

"But our policies, our internal policies, with regards to how we raise government revenue how we deal with the privacy and the confidentially of our clients is a matter we reserve as a sovereign entity and we will continue to do that," Mr. Turnquest said.

The DPM reiterated that the government looks forward to having the policies and legislative proposals in short order.

## BHCAWU New President Charts New Course

Newly elected president, Darrin Woods, and Team Phoenix dominated the polling charts last Tuesday, in The Bahamas Hotel Catering and Allied Workers Union (BHCAWU) elections.

Mr. Woods, now the former general secretary for the Union, said getting a registered industrial agreement is first on the agenda; their mantra, protection, empowerment, advancement and service.

"A part of what we want to start off with is our membership discount cards, where while we

negotiate a contract, as a part of empowering them we want to be able to stretch that dollar that they spend," he said.

"At various business houses they're able to get discounts, we also are partnering with first care, that they will be able to receive discounts on medical

"Whatever their monthly fee is, as a member of the hotel union, they will receive a discount off that monthly fee, and then wherever they go they'll be able to get medical attention.

"Also, we're partnering with the union health and welfare which is a major medical, which

our members will be able to buy into and they have a major med-

"In addition to that we intend to introduce an assistance programme for our members because the time has come now when there are times of disasters that the union members will be able to come to the union and receive even if it's an initial benefit," he added.

With just under 5,000 members eligible to vote, Wood said they're working on getting members reengaged with the Union.

"We're going to offer our service now to the members, improve our service to them,

improve benefits to the members, because we believe that if we improve the benefits to the members, they will reconnect with the union," he said.

"Because as opposed to just paying ten dollars a week and that's it, you'll be paying ten dollars a week and be able to receive some reciprocal benefits from the Union."

Mr. Wood said although over the year's progress has been made, there is much more work to be done.

"We are going to be focusing on the health aspect of our membership because we recognize that there are a lot of non-communicable diseases that our people are contracting and developing because of our lifestyle," he

said. "We want to develop and portray a more healthier industry, because if the members and the

employees are healthier they'll

be more productive on the job." Woods' competitors were Abraham Smith of Team New Day, Tyrone Knowles of Team Revolution, and Valderine Small of Team Destiny.

There were two polls in New Providence, one in San Salvador and one in Grand Bahama.

The BHCAWU will be 60 years old on December 1, 2018.

#### **FUNERAL DIRECTORS EXPERIENCE THEFT**

Apart from individuals with no formal training grossly undercutting the market, some Bahamian funeral directors also worry about persons stealing their equipment.

The Bahamas Funeral Directors Association's (BFDA) Public Relations Officer, Randy Curtis said that he lost \$50,000 in equipment one year as a result of stealing.

He said that these items included a church truck, a lowering device, and embalming instruments.

He said, "I use 'Slaughter' instruments, which is the top brand. It's the Rolls-Royce brand of instruments, and they're expensive, but they produce the kind of work that my clients are accustomed to and one year we had to buy three sets."

This is why the association is aggressively pursuing to propose legislation to government.

Last week this Journal reported that the BFDA was actively seeking to propose legislation to government which will regulate its practices.

This piece of legislation will seek to deal with theft within the industry.

Mr. Curtis said, "a lot of these persons who are coming into the field they do not have equipment and they want to ask you to borrow, but they would have someone befriend your staff and say 'Well, can I borrow so and so?' They never bring it back."

He added, "in the industry, I've heard of firms who would have lost up to \$7,000 worth of stuff out of the cemetery. If you got a lowering device for \$5,000, you've got \$300 or \$400 in chairs, you've got \$1,000 for the mat that you put around the grave, you could come back and the whole set up is gone."

Mr. Curtis also said that the BFDA is scheduled to be ready to propose to the government by the end of the year.

The 2018 series salutes fashion mogul Peter Nygard's Golden Jubilee detailing his rags to riches story and incredible business success over these past fifty years. The Clifton Review will take an inside look at how he did it.

"Will the real Peter Nygard please stand up." There are many sides to fashion mogul Peter Nygard as Marina Sturdza has shared in her 1987 article "Who is the real Nygard?"

Previously we highlighted several characteristics of Nygard that appeared to greatly contribute to his ability to make his business such a huge success. Sturdza also zeroed in on some of the ones we presented. Below are excerpts from what she shared in her article, which continues from Part I:

There's Nygard the perfectionist, who before launching his denim division, examined no fewer than 60 products, checking every detail, counting belt loops, pockets and the number of stitches per inch, measuring waist bands and checking logo positions. Nygard's own denim product was submitted to every conceivable wear and performance test, until it met his demands.

Even so, he ordered the production line stopped, when he zeroed in on a minor offending detail-and expensive three-week delay that cost the company thousands of dollars.

Similarly, for his classic Alia pant, available in 56 different colors, Nygard insisted on a costly onepiece waistband plus custom-dyed thread, buttons and zippers to match each of the 56 shades-all for a garment slated to retail at a ridiculously low \$26, that is churned out at the staggering rate of 30,000 a week.

There's Nygard the arch-competitor... a man whose compulsion to conquer and succeed in all his endeavors is seemingly endless.

All of the above are, or have been, the real Peter Nygard. But emerge with a remarkably limited portrait of the man, who's considerably more complex than he's likely to admit. Says Nygard: "What you see is what you get." Not entirely.

No one ever built a \$200-million clothing empire on mere flamboyance, hedonism, and a knack for selfpromotion, and nobody ever did it alone. And Nygard's ability to retain top-level executives ... is testimony to the caliber of Nygard's operation and the opportunities he offers. And the company's impressive growth record—Nygard International has never failed to turn a consistently high profit, and sales have doubled every five years—indicates that Nygard is clearly paying attention to business.

Nygard's route to fashion supremacy may not have been as glamorous as that of his higher-end designer market peers, but in North America, the middle-market is where the numbers are and where the profit lies. What's more, Nygard's record has greatly endeared him to his retailers, and will doubtless earn him a privileged reception for his next venture, a signature collection pitted directly against Canada's "better" manufacturers.

Nygard further protects his retailers' interests (and incidentally, his own) by providing thorough product information and staff indoctrination, plus enviable display and co-op advertising support. So effective are his tactics that Nygard's Canadian retail sales amount to \$4 per capita, for every man, woman and child in this country—all the more impressive when you consider the company's low price points—\$25 to \$150, and the sheer number of units represented. In total, Nygard produces 10 to 12 million garments a year in his Thunder Bay, Winnipeg, Los Angeles, Taiwan, Korea, Hong Kong and Chinese factories.

In fact, says Jim Bennett, the building's showroom and display facilities have already prompted an increase in orders. And, since Nygard intends to make his multipleuse building available to other designers and fashion organizations, it's also an elegant gift of space to the industry and to the city.

The interesting thing from this perspective is that it appears nothing has changed with respect to Nygard's approach to his business. We can see how his consistency has helped him to continuously achieve mega success while so many other retailers have gone out of business.

should be concerned!" And thus today, the lesson to be learned is to the effect that: --"...Time longa dan rope..." [English Translation]: Time is longer than a


rope! And thus, notwithstanding abiding fears and trepidations galore, there is some really good news now brewing.

#### **PUBLIC TREASURY DEPARTMENT**

The Treasurer of The Commonwealth of The Bahamas is conducting a new vendor verification exercise to prepare for an upgrade to its digital payment processing system on **June 15**. This will affect all individuals and businesses providing goods and services to the Government.

It is very important for all vendors to participate in this verification exercise so they do not experience any discontinuation of payments. Failure to participate in the vendor verification process will result in the discontinuation of payments.

Vendors must submit or confirm banking information and email contact information with the Public Treasury. This must be done by completing a Vendor Verification Form, available online (Go to www.bahamas.gov.bs, go to Forms top left click on vendor verification form and download).

For the past three years, the Public Treasury has been transitioning away from the use of cheque payments and other manual processes. This year, the Treasury plans to eliminate cheque payments all together. Payments will be made by direct deposit. And as of July 1, all notifications of payments will be sent by email. This will allow vendors to receive immediate notification when payments are sent to their accounts.
