According to Senator Fred Mitchell, fifty percent of the people who make under \$30,000 a year in The Bahamas cannot make ends meet at the end of the month.

### Leadership Changes At Port Department

Hutchinson appointed Acting Managing Partner of the Bahamas Maritime Authority.

After serving with the Maritime Bahamas Authority since 1996, Captain Hutchinson has gained a new role. He is now to serve as Governor of the International Maritime Organization (IMO) World Maritime University. The WMO is a postgraduate Maritime University founded by the IMO with the aim of further enhancing the objectives and of the IMO and its member states around the world. He is the "first Bahamian who will

serve the Bahamas in this global capacity, and as a Bahamian who continues to play his part in our critical Maritime Industry", says the Transport Minister.

"While completing this deal has proven to be very complex, and is taking far more time than we have hoped, our resolve and dedication remains high. This deal must get done," Mr. Thompson said.

The Grand Lucayan closed for repairs following the devastation wrought by Hurricane Matthew in October 2016. However, it never reopened.

The government has long been in talks with the Wynn Group to have the property sold, in hopes of restoring activity to the entire Lucayan strip as quickly as possible.

In addition to the emphasis being placed on this deal, the Minnis administration is also said to be in final discussions with investors of the Grand Palm Beach Acquisitions regarding a \$2.5 billion 10-year deal to revitalize the Ginn project in West End.

Senator Thompson said, "Grand Palm Acquisitions will construct, repair, revitalize, develop and operate a 246 room hotel and they will also have an additional two hotels, a banquet facility, a branded residence and also a

'They also anticipate having facilities for mega yachts, and what is interesting about this is, as a result of the technology hub initiative they have indicated that apart of their development will be a smart city where they will also be attracting technology companies, to set up their companies within the project.

"The government is now in negotiations on the heads of agreement and we are informed that in the first year the developers intend to hire approximately 200 Grand Bahamians," said Senator Thompson.

The minister's comments came in defense of the argument that there is nothing in the 2018/2019 budget for Grand Bahama, whose anemic economy drags on.

sultative committee worshiped along with Prime Minister Dr the Hon Hubert A Minnis and his wife Patricia, both members of that church.



But let us look at the Westminster System and how it applied to the Parliamentary Secretaries in the most recent case of voting in the House of Assembly. It is true that Parliamentary Secretaries are obliged to vote with the Government or offer their resignations

This is true under the Westminster System. But what is a Parliamentary Secretary and what role does he/she play in the Government?

In England, a Parliamentary Secretary acts almost as a Deputy Cabinet Minister. The position was huge Ministry, involving thousands of people. In The Bahamas, the Parliamentary Secretary is essentially a hired hand used to guarantee votes for the Government in the House of Assembly.

Most Parliamentary
Secretaries in The Bahamas
do nothing other than collect
extra money for the position.
But they are important to the
dictatorial way in which the
Bahamian Government has
operated for many years.

I remember in the early eighties Sir Lynden Pindling appointed two Parliamentary Secretaries. At the time both Sir Kendal Isaacs and Sir Cecil Wallace-Whitfield, along with the other members of the FNM in the House of Assembly, were vehemently opposed to it.

We maintained then that it was only a maneuver to put almost dictatorial power into the hands of the Prime Minister. Over the years the respective Prime Ministers, both PLPs and FNMs, appear to have used this method of controlling Parliamentarians. It has become a dictatorship.

Here's how it works. Let's say there are twenty-five members in the House, ten in Opposition, and fifteen in Government.

The Prime Minister appoints ten of the fifteen as Cabinet Ministers and five as Parliamentary Secretaries. The other ten are Opposition. The Cabinet members get paid as Ministers and vote in

Cabinet. The Parliamentary Secretaries get paid but don't vote in Cabinet, but, when the motion goes to the House, they must vote with the Cabinet.

For example, if six Cabinet Ministers are in favor of a motion to increase taxes, and four oppose it, the motion carries. In this example, if the five Parliamentary Secretaries oppose the motion, they can't vote their objection.

The motion now comes before the House for passing. Ten Cabinet Ministers MUST vote for it. Five Parliamentary Sectaries MUST vote for it. Ten Opposition members vote against it. The motion carries

Note, only six of the fifteen approved it!! Had the Parliamentary Sectaries been allowed to vote their consciences, the motion would not have carried. They simply said "yes sir boss", or "how high do you want me to jump ... on the way up"!!!

But the Government cries, "vote with us or we'll fire you!!!!! Dictatorship?

In my opinion, all Parliamentary Secretaries should resign their positions, and all Members of Parliament who serve as the Chairman of any Government Boards should resign as Chairman.

I suggest they become beholden to the people who voted for them. Stop being voting pawns!!

Instead, no matter what, the poor know that they always more and thus they sometimes in resignation to their fate in life, they conclude: -- "It's just one of those things!"

This is how some in this tribe respond when asked about their take on this or that contentiously debated and discussed public matter.

What we know for sure is that: -- Despite public protest; regardless all those reams of fears expressed across the board or for that matter those big decisions made by some of them nominally in support of their side in the House; or for that matter, any number of egos left bruised and crushed; the Minnis regime will have the last word---if only for now!

Here we suspect that Gaming Shop impresario, Mr . Craig Flowers, himself no stranger to high-level work and yeoman's service, is on to something very important as he counsels against anything that looks like panic-induced action.

In this regard, then, please note that: -- Unlike some of those other players in the Web Shop Operator world, Craig Flowers indicates that he is not prepared to announce layoffs before he can determine how his customers react to the decision to tax deposits..."

This is wise!

In addition, then, Craig Flowers, CEO of FML Group of Companies went on to explain: -- "My reasoning behind that is certainly we would have

in the industry probably the longest serving employees by the very nature of us being the oldest company as it relates to online gaming locally.

"We have more of a family type operation with our staff members and for us it is very important from the administration [level] to constantly assure our staff that we are going to do everything possible to secure their jobs...At the end of the day, the only determining factor that will be of any consequence to ourselves will be the response of the customers..."

Again, Flowers is direct, to the point – and clearly, also, wise enough to know that – when it is all said and done-the customer is king!


[And yet again], Flowers is on the money when he points out that: -- "...All of the remarks being made are pre-emptive here because none of us, including the government, is going to determine the future of this industry. The [people] who will determine the future of the industry are the customers...From FML's perspective, we want to be very optimistic. [We believe that]: -- The industry will overcome this very difficult time... and we believe [at the end of the day] that: -- The industry will win over all else."

And thus, the title of today's commentary: -- It's just one of those things.

On May 30, the government revealed that gaming house revenue up to \$20 million will be taxed at a rate of 20 percent; revenue between \$20 million and \$40 million will be taxed at a rate of 25 percent; revenue between \$40 million and \$60 million, at a rate of 30 percent; revenue between \$60 million and \$80 million, at a rate of 35 percent; revenue between \$80 million and \$100 million, at a rate of 40 percent and revenue more than \$100 million at 50 percent.

The government has also proposed taxing gaming patrons through a five percent stamp tax applied on deposits and any non-online games or digital sales.

The increases take effect July 1. [2018].





### This Time in Medicine is Exciting and Challenging for Doctors

Minister of Health, Dr. the Hon. Duane Sands said this time in medicine is both a particularly exciting and a particularly challenging one for

"How you deal with these challenges will determine your staying power in the profession," Dr. Sands said at The University of the West Indies School of Clinical Medicine and Research & the Ministry of Health's 'Induction and Awards Ceremony for the Graduating Class of 2018' held at Baha Mar, Sunday, June 24, 2018.

In attendance were Prime Minister. Dr. the Hon. Hubert Minnis; Vice Chancellor, University of the West Indies, Sir Hilary Beckles; and Director, UWI School of Clinical Medicine and Research, Dr. Robin Roberts.

Dr. Sands said, "Newly-minted doctors, you are entering a profession now dominated with chronic noncommunicable diseases, and the sad reality is that you may oftentimes

have to convince the very patients you hope to get well that they even have a problem."

He said, "We all have heard obese or overweight people say that they are just big boned or solid; or diabetics that swear that they have a touch of sugar; or the out of control hypertensive say they just 'gat a lil bit a pressure'. Such 'bending of the truth or these pleasantries' ease the need to wrap our heads on the brutal reality of diseases that kill and incapacitate."

The Health Minister said the social determinants of health are largely sadly outside of the control of the traditional doctor, no matter how wellintentioned.

"We continue to have the worst profile of Non-Communicable Diseases (NCD's) in the Americas, and the highest rate of HIV/AIDS outside of Sub-Saharan Africa.

"Hundreds upon hundreds of our people are afflicted with kidney failure requiring dialysis at a cost of \$50,000 - \$80,000 per patient per

He said the efficient and effective

approach to the country's medical challenges demands routine and appropriate screenings, medication when needed, restrictive dietary changes and an abandonment of the lifestyle that shuns physical exercise.

Dr. Sands added that everything from policy to service delivery should assist the Bahamian people in making wise and healthy decisions and adopting a healthy lifestyle.

He explained that 45 years ago, a revolutionary social idea gave way to the creation of a national breadbas-

Dr. Sands said it was the kind of initiative that was revolutionary at that time.

"In 2017, on reviewing the 45year-old Bread Basket list, we realized that the items included were not ideal. Many were calorie-dense and nutrient poor with a number of items which, when combined with an inactive lifestyle, increase the risk for becoming overweight, obese and developing one or more NCD's."

He said the breadbasket was a progressive social initiative and the

drafters could not have known that an initiative that saved many from malnutrition by allowing a belly-full would become, in part a reason for the epidemic of obesity, hypertension and diabetes, heart disease and kidney failure.

"Instead of being underfed and malnourished, we are overfed and malnourished."

The Health Minister said the Government has committed to an extensive national consultative and educational campaign, which has been ongoing but not yet complete. He said the importance of this initial and ongoing engagement with the public cannot be understated.

"When we complete the consultation, we expect that the revised, agreed list will be gazetted by the Minister of Labour on the advice of my Ministry. There will be no need for any additional legislation."

Dr. Sands said because there have been overwhelming views expressed on two items to date, sugar will definitely not be on the price control protection list.

He added that Corned Beef was found wanting, was weighed in the balance, and was granted clemency. It is on probation.

Dr. Sands said moving forward, he anticipates that the Government shall work to achieve consensus to remove margarine, condensed milk, mayoncanned meats (SPAM, Vienna sausages, etc.)

The Government expects to add:

Beans and Peas (a healthier source of protein and minerals.)

Raw Almonds and cashews

Fresh oranges

Fresh apples Root crops (sweet potato, pumpkin, cassava, Eddie, Irish potatoes)

**Oatmeal** 

Tuna, sardine and mackerel in Water

Healthier milks

Healthier flour (whole wheat, spelt, Quinoa, Coconut, glutenfree, rice, unbleached white)

> **Healthier bread (Whole** grain, whole wheat)

**Healthier Butters and Oils** 

Healthier rice

Dr. Sands said it is expected that the combination of VAT elimination and price control (18 per cent and 21 per cent) will not only make healthy naise, canned soups and broths and foods less expensive; they will actually be affordable.


### RBPF 25TH ANNUAL SUMMER YOUTH PROGRAMME OPENS WITH CHURCH SERVICE
