ne week after being fired, Bains and Grants Town MP, Travis Robinson, yesterday reconfirmed his commitment to support the governing Free National Movement.

"My integrity is not for sale, my conviction is not for sale, my one vote is not for sale," Robinson said.

Contrary to the assumptions made, according to the MP, his decision last week to vote against the 4.5 per cent Value Added Tax (VAT) increase was not on a whim, neither on the basis of misinformation, but

after much consideration.

Mr.Robinson said his decision had everything to do with the promise he made to his constituents on the campaign trail to fight for them, stand up for them and speak out for them - even if it caused him his livelihood, and that it did.

The Bain's and Grants Town MPalong with two others - was immediately fired as a Parliamentary Secretary after they voted against the VAT increase.

The Westminster System requires a Parliamentary Secretary to support his government's policies and actions.

In a communication to The House of Assembly yesterday, Mr. Robinson fully accepted the conse-

quences of his actions.

"No system of governance, no position or money enough, will cause for me to yield my personal belief or conviction, especially when my people need me the most," he said.

"But you see Mr. Speaker, [mine] is a story of young black educated Bahamian male from Bain and Grants Town, whose poverty knew no end

"My no vote in this honourable place was in alignment with my low and meek rise from the dust of poverty," said the youthful MP.

Mr. Robinson assured though, that despite his firing, he and the Prime Minister continue to enjoy a remarkable political relationship, akin to a father and son.

"I wish to announce once again my continued pledge and support to the Free National Movement, as I am sticking with the FNM."

To his constituents, who must shoulder the shared burden of an increased tax, he asked that they - as in the case of all Bahamians - not give up.

"It is at our weakest point that we need our greatest strength in order to triumph," he said.


"Let us be creative, enterprising, and determined every day not just to survive, but to help others to survive and move from mere survival to thriving.

The Princess Margaret Hospital (PMH) has opened its doors to 40 of 49 new graduates of the University of the West Indies for a one year internship, according to Health Minister Dr. Duane Sands.

MP WANTS New System of Governance

The Member of Parliament for Bain and Grants Town and former Parliamentary Secretary in The Ministry of Tourism, Travis Robinson has called for a select committee to evaluate the Westminister system of government in terms of its relevance, effectiveness and continued adherence in the 21st century Bahamas.

The young MP addressed what he called "the elephant in the room," in the House of Assembly yesterday.

The MP spoke for the first time publicly since his appointment was revoked by the Governor General on the advice of the Prime Minister.

Mr. Robinson told House members, "It is my fundamental belief, that no member should be placed in a position to choose between their party/government and the people they represent in this honorable house.

"Such a position is to put a strangle hold around the neck of the Bahamian democracy, choking the life out of it.

"In a democracy, power flows from the citizens to the government, but the vote is not the end all and the be all," he added.

He said, "we cannot be satisfied with participation that is limited to going to the polls every five years.

"If we are to have a strong healthy democracy we must all participate.

Six Haitians Arraigned on Drug Charges

Six Haitian Nationals were arraigned yesterday on one count each of possession of dangerous drugs with the intent to supply and conspiracy to possess dangerous drugs with the intent to supply, conspiracy to import danger-

ous drugs and importation of dangerous drugs with intent to supply.

A drug bust on Inagua last Saturday landed the six accused before Deputy Chief Magistrate Subusola Swain.

The group, which included a 17-year old female, all pleaded not guilty to all the charges except the captain of the vessel.

The six consisted of the captain, Clodius Michel age 30; Monique Tilme, 48; Ronel Guillaume, 39; Georges Merandieu Decimus, 50; Solane Pierre, 57 and Lissanka Jean age 17.

Magistrate Swain told the juvenile's mother that she may get bail because she has her mother who has residency here.

However, they entered the Bahamas illegal-

ly and as a result they would have to be handed over to the Department of immigration after all court proceedings are completed.

The captain who pleaded guilty was sentenced to five years on each count, the others were remanded in custody until Friday.

The six were found with 40 pounds of suspected cocaine.



"Everyone cannot physically sit in these seats, or be Cabinet ministers, but there is no shortage of work to be done."

The MP urged Bahamians to familiarize themselves with the Westminster system.

He added that many also suggested to abandon the centuries long system.

However, before doing so, the MP said there are many steps to be taken before arriving to that conclusion - there must be a place for questions to be posed.

The MP suggested creating a hybrid system of government

"A proposed system of governance, that selects the best aspects of the Westminster System and parts of a republican system, to form a hybrid system of governance for The Bahamas, specifically tailored to shatter the glass ceiling and reach the height of true democracy," he said.

"A hybrid system of governance where no member in this honorable House of Assembly, will be ever be fired again, for choosing between a fundamental belief and the direction of his party.

"Let my termination, and

that of my other colleagues, be the last of its kind."

The MP was terminated along with two others, for voting against the government's July 1st increase of value added tax (VAT) from 7.5 to 12 per cent.

Under the Cabinet Manual of procedure, a Parliamentary Secretary is a part of the government and as such cannot publically express his disagreement with a decision of the government.



The Rough Cut

"...oh-ho dear..."

"They're nasty... [The police] scared us. We came here; we spent our money and what are they doing? They beat the woman. They're showing us bad things. They should not do that. It's scary because you know you have lots of tourists here. They should cut it out. The policemen are a little too aggressive here. Just let them tour... let them serve us. We're coming here because of the people. Don't be aggressive here."

Oh-Ho dear what can the matter be...oh dear; ho dear, who cares anymore... And so the hurt continues; and as police beatings make the headlines and [sadly] the same tired-assed politicians are bleating like lambs on the way to the slaughter -with some bleating about national security and others bloviating nonsense galore about majority rule.

Sure seems as if contexts do matter when you set about that nasty business of wishing or wanting to kill people.

From what I am hearing, some tourists are not coming back to the Bahamas - ever! "They said they're not coming back here because if this is the way the police treat Bahamians they don't want to return."

As some of them are said to have described the police... They're nasty... [The police] scared us..."

Here I end as I might not have wished but nonetheless. I have for you some real blam/gadjammit coming from the bloodied eye of that storm coursing its own destructive way through these islands, rocks and cays that belong to so very many foreigners.

The facts are clear and simple enough: A pre-school teacher was shot about the body multiple times with a shotgun by a lone gunman on Sunday night, leaving her school community in a state of shock and her family devastated.

According to police, Denise Adderley, 39, of Chippingham, was at Texaco Service Station on Wulff Road and Kemp Roads when she was shot.

Adderley died on the scene.

A man was arrested and a shotgun seized, according to police.

There it is: the real McCoy in today's blooddrenched Bahamas Blam/gadjammit!

In the meantime – as the following news excerpts reveal – the beat continues.

Story number one concerns an event that involved two women, a fight, some biting and fine some facescratching - and a bevy of shocked tourists.

Here I am told that, "...Tourists and Bahamians looked on in horror as a police officer allegedly beat a woman before hauling her off to jail yesterday in the area just behind the downtown straw market.

Edena Farrah is the name of the woman who was allegedly beaten by an offduty officer for reasons that are still unknown.

Now note this: "The lady (Farah) was on the scooter with about 12 tourists following her... She stopped and was talking to the tourists, and the police woman, who wasn't even in uniform, grabbed the woman by her hair and started to beat her..."

And then we have the question: "How could we have policemen in the force like that? The police should not be [acting] like that..."

Thereafter I am told that, some of the tourists on the tour chimed in with color commentary to the effect that, the police who beat the woman was truly nasty.

"They're nasty... [The police] scared us. We came here; we spent our money and what are they doing? They beat the woman. They're showing us bad things. They should not do that. It's scary because you know you have lots of tourists here. They should cut it out. The policemen are a little too aggressive here. Just let them tour... let them serve us. We're coming here because of the people. Don't be aggressive here."

And then there was even more commentary: Referring to the vendors who had served her earlier in the day, the woman added: "These are lovely people. The police should help - not hurt."


"They're nasty... [The police] scared us.



Now that they have done their VAT+THING. we who must now bite this newest of tax bullets must - [as a matter of the most urgent priority]-understand that another far more important issue merits urgent attention, with that matter being any number of hurricanes on their way.

Evidently, therefore, even as they now rush to explain their volte face on the tax in question, the fact remains that all of their rosiest of hopes as regards VAT run the real risk of being left bruised, damaged or outright destroyed by damage done by wind, rain - and pestilence unleashed on the

In this regard, then, we report that: -- Sebastian Acevedo, author of "Gone with the Wind..." points out that the average disaster caused damages of US\$352 million (in constant 2010 USD), with damages from more intense storms, normally causing larger damages as expected.

The study, we are told, provided a quantitative analysis of the economic costs of hurricanes in the Caribbean

As Acevedo shows: -- "The impact of a natural disaster is felt mostly in the destruction of the capital stock; that is, damages to housing, agricultural crops, roads, buildings, etc. Since the capital stock, in monetary terms, is usually larger than the total production of a country on any given year, it is possible to have disasters that destroy more than a 100 percent of GDP..."

And thus it follows that in the event of such an external shock—the VAT TAX Matter will, no doubt, take on the characteristic of being little more than prologue to that issue which - all things considered matters most.

As climate chaos unleashes its uneven and combined disasters, its impact is particularly apparent in big cities. Two great tides are converging on the world's cities today, and as a result, we are seeing one of the greatest threats to the sustainability of urban existence. The first of these is a human tide. In 2007 humanity became a predominantly city-dwelling species.

Of the approximately 7 billion humans currently living, 3.3 billion live in cities. But if the human condition is now an urban one, this urban humanity is not spread evenly across the world's cities.

Here we might show: -- According to the World

Travel and Tourism Council, the Caribbean [Bahamas included] is the most tourist-intensive region in the world.

This makes Caribbean economies particularly vulnerable to the vagaries of Mother Nature.

In addition, note well that: -- The World Travel and Tourism Council predicts that the Caribbean will become the most at-risk tourist destination in the world between 2025 and 2050.

Interestingly enough, the UNESCO Science Report observed that 'the region would be hardpressed to deal with a major meteorological disaster,' and urged it to 'take climate change adaptation

As important are findings which show: -- "In the past as in the present, the fossil capitalism that is driving planetary ecosystems toward a mass extinction event was adopted for the profit of a miniscule but powerful global elite."

And thus that paradox where: -- The great global majority who are least responsible for carbon emissions are suffering the most from climate chaos; which brings us to that place where: --Some observers now broach vexing questions about the uneven global impact of climate change and about the viability of an economic systemfossil capitalism-that is predicated on ceaseless expansion on a finite planet.

And for sure-as some of the weakest in this world of the strong—we are told that: -- Hurricane and climate change costs in the Caribbean over the past 65 years amount to US \$52 billion (in constant 2010 USD) for the 148 disasters with information on damages.

What we know for sure is that such damages involve processes of subsidence and coastal erosion- which once taken together-destroy natural barriers that protect cities from increasingly severe storms and their surge waters.

Of necessity, then, every island, rock and cay in the Bahamas is on the so-called hurricane hit list!

Evidently: -- The area's most prone to such disasters extend in a band across the planet's tropics, including urban regions in Central America, the Caribbean, the Bay of Bengal, China, and the Philippines.

We are smack dab in the middle of these scary realities.

Maritime Security, 'Critical' For The Bahamas

Maritime Security is 'particularly critical' for The Bahamas, given its makeup as an archipelagic nation, said Minister of Transport and Local Government, the Hon. Frankie Campbell: borders are extremely porous, as the country features a vast expanse of water covering an area of 100,000 square miles.

The Minister delivered opening remarks at a workshop and roundtable discussion on 'National Maritime Supply Chain Security in The Bahamas' at the Paul Farquharson Conference Centre, June 26-28, 2018.

"Due to The Bahamas' geographic make-up, there is a great need to maintain constant vigilance, ensuring that maritime security remains at the highest level at all times," said Mr. Campbell, adding it is evident that the stability of The Bahamas' economy requires

that the country's maritime industry be protected at all costs. "In this regard, I am pleased to emphasize that all of the major port facilities in the Bahamas meet international ship and port facility security (IP code requirements). And are supported by 24/7 security presence."

The Minister said that it is, therefore, of paramount importance to partner with neighboring countries and participate in workshops such as this one to promote

the vigilance required for maintaining secured borders.

The three-day conference comprised interactive sessions facilitating increased information-sharing and analysis and inter-agency coordination, with a view to identifying opportunities for enhancing related policies, procedures and mechanisms at both the port and national level among key stakeholders within the Bahamas' maritime industry.
