

Restaurant Bahamas Limited Signs Industrial Agreement

Bahamas Restaurant Limited signed a 5-year industrial agreement with the Bahamas Hotel Managerial Association.

Restaurant Bahamas Limited is the company responsible for Kentucky Fried Chicken outlets in The Bahamas.

Noting that this is first industrial agreement of 2019, BHMA president Obie Ferguson said he

hopes industrial agreements to follow will take similar positions.

"This industrial agreement covers basic public holidays, Christmas bonuses, and it establishes a minimum notice period in case of termination.

"It also includes an increase in wages, it includes a signing bonus and it also makes provisions for another bonus throughout the life of the agreement.

"This agreement also includes insurance benefits for the workers and also if you're lucky enough to have a birthday it also provides for a day off with pay on your birthday.

"It is a very comprehensive agreement and it covers basically all of the general terms affecting workers," he said.

Mr. Ferguson thanked Restaurant Bahamas Limited negotiators for making this process peaceful and respectful, noting that during the process nothing blew up in the media.

He added that workers whom this agreement affects, need not be concerned about termination.

"It was very respectful and finally we reached an agreement which is comprehensive and inclusive for these workers."

"They need not worry, certainly as to how they can be terminated, because the process by

which that is done is embodied in this agreement," Mr. Ferguson said.

The Union leader added that he hopes agreements to come are achieved amicably as these are difficult times as worker's right s have been challenged, especially in the courts.

"Things we had pre-1958 seem to all now become a matter for litigation. So it behooves us to do what is required,"

This agreement has been under negotiations for the past 5 years and while there has been no contention, Mr. Ferguson said they allowed this because they understood the situation at the company as the matter was before the tribunal court.

This agreement covers Kentucky Chicken restaurants in The Bahamas which includes some 40 supervisors and managers.

other people's lanes. I like to talk about my stuff. Don't ask me about rapes."

In a statement yesterday, the Minister said, " I am humbled at the opportunity to speak to mothers, fathers, women and girls, victims of rape, abuse and violence, and anyone else who may have been offended by a video recording of me that is in circulation."

He said, "I am fully aware of the duties and core functions of the Ministry of Social Urban Services and Development which includes, but is not limited to, food assistance, shelter for all victims, including rape victims and victims of trafficking in persons, school and uniform assistance, the elderly, child protection, rehabilitation and persons with disabilities."

Mr. Minister said "this

incident has caused persons to question my familiarity with the 2015 Strategic Plan to address Gender-based violence. I am pleased to note that in the six months that I have been the Minister, I have partnered with the Crisis Centre, the Caribbean Men's Group, the Zonta Club, the Pilot Club, the United States Embassy, UN Women and a number of NGOs in an effort to bring this very strategic plan to fruition.

"I am committed, along with the Ministry and its dedicated staff and all of our NGO partners, to honour, advance and promote all of the Conventions to which The Bahamas is a Signatory," said Mr. Campbell.

He added, "In pursuit of the commitment articulated during the 2017 Speech From the Throne, the government has indicated a Zero Tolerance against all rapes and violence. Efforts to prevent violence against women require determining and addressing violence at its root. The Ministry of Social Services and Urban Development, through its many Departments does precisely this, through the provision of counseling and crisis intervention and prevention services.

"As a husband and the father of one son and three beautiful girls for whom I want nothing but the best, as I do for all girls and of women

Bahamaland, this is more than just a job.



REAL PROPERTY TAX NOTICE for 2019

In accordance with the Real Property Tax Act, Chapter 375 as amended, the Chief Valuation Officer hereby gives notice:-

- (a) that copies of the assessment lists are available as required by Section 7 subsection 7 of the Act, and may be inspected at the Office of the Chief Valuation Officer;
- (b) that a notice of assessment addressed to each owner of property liable to tax under the Real Property Tax Act is available at the Valuation Office, located at rear of the shops at Carmichael Plaza, Carmichael Road and may be collected therefrom by or on behalf of the owner of such property during normal working hours;
- (c) that pursuant to subsection (3) of Section 7 of the Act, upon the expiration of five days after the publication of this notice, a notice of assessment shall be deemed to have been served on every owner of property liable to tax under the Act;
- (d) that without prejudice to the provision of subsection (3) of Section 7 of the Act, the Chief Valuation Officer may at any time after the publication in the Gazette of this notice send by post, a notice of assessment addressed to any owner of property liable to tax under the Act;
- (e) that pursuant to Section 11(1) of the Act, any person aggrieved by a notice of assessment deemed to have been served under this Act may object thereto by serving on the Chief Valuation Officer within thirty days after the date on which the notice of assessment is deemed to have been served, a notice in writing of such objection stating the grounds upon which he relies;
- (f) that pursuant to Section 18 of the Act, the tax is due and payable by the owners of property not later than sixty days after the date on which notice of assessment is deemed to have been served. Accordingly, it is the duty of each taxpayer to ensure that he receives a Notice of Assessment;
- (g) that the exemption has been allowed for 2019 on those which have been declared as owner-occupied residences, and have satisfied the conditions. However, under Section 43 of the Act, the owners are required to disclose to the Chief Valuation Officer any change in the circumstances which does not entitle the property for the exemption allowed;
- (h) that pursuant to Section 10 of the Act, every owner of property shall not later than the thirty-first day of December in each year, make to the Chief Valuation Officer in the prescribed form a return of such particulars of that property as may be prescribed, for the purpose of enabling that Officer to compile and maintain accurate assessment lists, and such owner shall declare to the correctness of such return before an authorized person.

Smith did meet Hanna before the awarding of the contract, based on Hanna's own testimony.

Mr. Jenkins told the court that Hanna's prior testimony about speaking with the former PHA chairman in 2016, which was after the board had already made a decision on the contract, was "a mistake in dates on the part of the witness".

Mr. Jenkins added that what Mrs. Hanna meant, was that she met with Smith in 2015 and not 2016, despite her testimony.

The crown proceeded to give a chronological recount of what took place leading up to the awarding of the cleaning contract for the cleaning of the hospital.

The crown further contends that if presiding Chief Magistrate Joyann Ferguson-Pratt concludes that there is no evidence of a meeting between Smith and Hanna, the bribery charges fail.

However, lead defence attorney for Smith, Queens Counsel, Keith Knight reverted to the testimony of Hanna, whom he said testified on more than one occasion that she met Smith in 2016.

In Tuesday's proceeding, Mr. Knight dissected the testimony of Hanna,

attacking her credibility, insisting that Hanna lied giving inconsistent evidence throughout her testimony.

The defence attorney further claimed that if Hanna was extorted, why did she continue to borrow from the "extortioners" lending company, Pouland, and this despite knowing of other lending institutions.

Besides seeking to pick apart Hanna's credi-

bility, Mr. Knight also sought to poke holes at her testimony that she felt she was testifying under pressure and against her will and that she was being used.

Mr. Knight wrapped up his no submission case by revealing what he called defects in the prosecution's case, inclusive of: "the documents presented by the crown corroborates the defense arguments that evidence from PHA tends to contradict the crowns case and where it doesn't contradict, does not support the evidence given by Hanna.

The crown contends that Barbara Hanna paid Frank Smith \$5,000 per month between 2016 and 2017 after he assisted her securing a cleaning contract for the Critical Care Unit of the Princess Margaret Hospital.

The trial resumes today.

Bahamas Hotel Managerial Association Obie Ferguson said, "certainly, I will not be moved by nonsense."

He added that they are still deep in negotiations with Lucayan Renewal Holdings Limited over VSEP packages for managers of the Our Lucaya Resort

Mr. Ferguson chalked that up to the fact that the ideas and projections of the current chairman have been what he called, "unreasonable."

"He moved from \$2.7 million and we're now to \$3.2 million, I think. We are of the view that it has

to be \$4 million on the basis of a simple formula.

"If you work for a company for 21 years, the assessment has to be based on 21 years, that's the way it was in every voluntary separation package.

"BEC was the same, Water and Sewage will be the same, Batelco was the same and the beat goes on, that's the way its done," he said.

According to the union president, \$1 million has been shaved off the settlement, taking it to \$4 million plus an annuity of what was negotiated from 7 per cent to 4 per cent of workers pay.

Despite the stenching,

he added that workers he said are still standing firm.

"My Vice President in Grand Bahamas had a meeting two days ago and about 99.9% of the workers are standing firm and why wouldn't they?

"How could they agree to accept less than what the law provides? Not only that they will now be going on the streets, not like they have a job after


"Bahamians aren't stupid, I can assure you that Bahamians aren't stupid people," Mr. Ferguson said.
