The Royal Bahamas Police Force has begun a month of activities with walkabouts in communities in New Providence with members of the Bahamas Christian Council as well as the media.

The walkabout takes place in various innercity areas like Bain and Grants Town, Englerston, Fox Hill,

Town, Nassau Free Village, and Carmichael.

Police Commissioner Anthony Ferguson said the idea is to show residents that he and his officers are one with the community.

cerning the recent eruption of violence in Haiti.

Mr. Henfield said that the island nation's foreign minister gave the heads of the conference a report on his government's view of that situation.

At the end of the day, he said, the conference should hone in on CARICOM's efforts to improve the circumstances in that country.

"We all agree that it's

an economic problem. Haiti needs to be infused somehow through commercial enterprises, and we've agreed to encourage our nationals and national companies through the various ministries or the Chamber of Commerce to delve deeply into what exists in Haiti for business.", he said. The minister added that

if the economy of Haiti can be improved by providing business opportunities for Bahamians, this will encourage more Haitian citizens to remain home rather than risking their lives in sometimes tragic sea journeys.

A total of 207 Haitian nationals have been apprehended for the year.

This number excludes the 31 bodies recovered from the waters off Abaco after their 40-foot conventional yacht struck a reef and sank on Saturday 2 February.

Last year, at total of 1,172 Haitians were apprehended.

serious injuries and succumbed on the scene.

In a release issued yesterday, the RBPF indicated that officers from the Traffic Department in New Providence were in South Andros yesterday assisting in the investigations.

Meantime, police in the capital are seeking the public's assistance in identifying and locating the persons responsible for a shooting incident which also occurred this past Saturday.

According to reports, shortly after 11:00pm, three males were sitting outside a home on East Avenue, Millers Heights when a group of males armed with firearms, opened fire on them.

Three of men were shot and taken to hospital in a private vehicle where, they are listed in serious condition.

The culprits reportedly fled the scene in a grey Honda Accord.

Police are also on the hunt for a male who

allegedly abducted a female child from a yesterday.

According to reports, shortly after 2:00am, a man entered a home off of Wilton Street where he abducted a six year old female.

A short time later, the

child was discovered walking in the area of Woodland Gardens by a passerby and taken to the Wulff Road Police Station.

Investigations are ongoing ,and a male is in custody assisting police.

states.

Chenuil-Hazan made this plea to the government during an interview with The Bahama Journal at the 7th World Congress judges can exercise discretion and should sentence only "the worst of the worst" and the "rarest of the rare" to death.

According to Chenuil-Hazan, breaking away from the "fake solidarity" would lead The Bahamas to a formal moratorium on the death penalty. He suggested that The Bahamas embrace the United Nations General Assembly Moratorium Resolution and not continuously follow other Caribbean countries by voting against it. "The Bahamas should Chenuil-Hazan vote," said. "It's normal. It's logical. Dominica should vote in favour, but they don't just because of this strange solidarity. You should go beyond and have your own identity based on your own situation." In a report released by the Advocates for Human Rights, The Greater Caribbean for Life, and The World Coalition against the Death Penalty, The Bahamas has voted against every United Nations General Assembly Moratorium Resolution and up until 2012, The Bahamas also signed the Note Verbale of Dissociation from the resolution each year. If The Bahamas receives a formal moratorium on the death penalty, the country would be globally recognized as a state with a moratorium on executions. Amnesty International identifies countries with formal moratoriums as states or territories where the death penalty is implemented, but no executions have been carried out for at least 10 years and which did not oppose the

latest United Nations Resolution for a universal moratorium on executions.

In addition, Chenuil-Hazan also suggested that the government should begin to shape the public's opinion so that Bahamians who are in favour of the death penalty would understand that the death penalty is not a deterrent to crime. Using China as an example, Chenuil-Hazan explained that thousands of Chinese are executed each year, but there is no decrease in China's crime rate. "So when you execute hundreds and thousands of people every year, you take the risk of becoming a dictatorship and break the rule of law," he explained. "Do you want to be in a democracy with rule of law or in a dictatorship with hundreds and hundreds of killings?" The ECPM director added that the government should have a strong willingness to educate Bahamians so that public opinion would change and Bahamians would understand that ending the death penalty is a part of entering a new world that has been embraced by countries in South America, Europe and Africa.

Against the Death Penalty in Brussels, Belgium where he expressed concerns over The Bahamas keeping the death penalty as law and not using it. Other English-speaking Caribbean countries do the same and Chenuil-Hazan considers this practice as a bad example.

"It's kind of shaming and I don't like shaming," he said. "But it's a reality of original solidarity. I think that some countries in the Caribbean should stop this fake regional solidarity."


Although The Bahamas is identified by Amnesty International as one of the 52 retentionist states around the world where the death penalty is implemented, The Bahamas has a de facto moratorium on the death penalty.

The last execution took place in The Bahamas in 2000 when Bahamian national David Mitchell was hanged after being convicted for the murders of two German tourists. Mitchell had an appeal pending before the Inter-American Court of Human Rights at the time of his execution.

However, the imposition of the death penalty in The Bahamas is no longer mandatory following a Judicial Committee of the Privy Council's decision in a case which ruled that

While abolishing the death penalty may be complicated for some to understand, applying it increases crime, according to Chenuil-Hazan.

"Applying the death penalty would bring violence, state violence," Chenuil-Hazan said. "The death penalty is a violence, when you kill someone. It is a violence and it is a symbolic state violence."

have met the March 1st deadline, according to FNM Chairman Carl Culmer who spoke yesterday in a telephone conversation with The Journal.

The rush came about after House Speaker Halson Moultrie reminded the Members of Parliament at the last sit-

۲

ting of the House of Assembly this past Wednesday that they had 48 hours to complete the declaration.

The Public Disclosure Act requires senators, members of parliament, senior public officers and public appointees to declare assets, income, and liabilities as at December 31st , before the 1st of March. Health Minister Dr. Duane Sands and Exuma and Ragged Island MP Chester Cooper posted their disclosure receipts on their social media pages this past Friday.

Meantime, Progressive Liberal Party (PLP) Chairman Fred Mitchell announced on Friday that all PLP parliamentarians "have complied with the provisions of the Public Disclosure Act 1976, by filing the executed Form A".

According to the Act, if anyone is found guilty of an offence, they will be liable of "conviction on information".

If the information or anything contained in a declaration, or other document published is untrue, offenders are subjected to a fine not exceeding \$10,000 or to imprisonment for a term not exceeding four years or to both such fine and imprisonment.

In any other case, they will have to pay a fine "not exceeding \$5,000 or to imprisonment for a term not exceeding two years or to both such fine and imprisonment".

All declarations are examined by the public

disclosure commission.

The commission comprises of a chairman, a secretary and two members who are appointed by the Governor General on the recommendation of the Prime Minister, after consultation with the Leader of the Opposition.

Two cabinet office staff members are posted there to perform administrative duties.

into the Nissan Lafesta to retrieve the baby.



PASSPORT WOES, Part 1

LETTER TO THE EDITOR

I am writing this letter on behalf of us, the Bahamian people, in the spirit of constructive criticism and with suggestions for improving the woeful passport office experience. I am certainly thankful that this is but a 'onceevery-10 years' occurrence because my recent experience was a two day/7 hour debacle.

Preparation – I made my way to the passport office late one afternoon last month, but was told to come back the following day because the quota had already been met for the day – okay that was understandable. Before leaving I asked for an application form (seeing as the online website I had used was probably not up to date) and was told to get that information from the office at the front of the building – no problem. Armed with these papers, I decided to return the following week after half term was over, as apparently persons had been lining up with their school aged children from as early as 5am every day that week in order to get their passports!

The following week - Day 1, I arrived at the passport office at 7am to renew my e-passport with documents in hand as outlined on the information form I had taken away the week before. There were still a few parking spaces available and a good crowd was present. After trying to find the end of the nonexistent line, I inquired of one of the persons what the procedure was and he indicated I was to make my way through the haphazard mass of persons standing around to get to the lady by the door with the pad of paper and put my name on the 'list' - which I did, moving back into the crowd afterwards thinking that was a positive sign since at least a record was being kept of the order of who came when.

Amongst the ever growing crowd, there were a few lucky souls who had found a place to sit on one of the only two narrow rickety wooden benches on site that had no back support. Well, at least many of us were squeezed under a canvas cover and there was a cool breeze blowing!

I was glad I had brought the daily paper to read since there was nothing of interest to keep one's attention as we stood outside patiently waiting, and waiting, and waiting.....during which time I surveyed the area and thought – why aren't there any seats (with back support) allocated for senior citizens, why aren't there any signs explaining the procedure (seeing as they had a locked cabinet attached to one of the walls – that was quite empty but it should contain a check list of what documents one should have so as to make sure your papers were in order before

new person who came to the door was told to come back the following day as the passport office had already filled their quota for the day, and many of us were still standing outside. I gratefully was able to find a space on the bench as persons went inside, but since the bench sunk down at the back against the wall underneath the empty cabinet, I decided it was less hazardous to stand, which most of us continued to do.

Lo and behold around 11 am (4 hours later) an office member came back outside to inform us that all those waiting outside could not be seen that day, and should come back tomorrow!

Needless to say, that announcement did not go down well! I for one found it totally unacceptable and voiced that view strongly, asking to see the supervisor. After 4 hours standing up, with my name on a list, and with 5 hours still remaining in the work day for passport office staff - to be told to go home and come back - they could not be serious! We were flabbergasted by this nonchalant attitude and disregard for customer service! Some citizens said that they had been told that the day before and now that would mean they had to take time off from work for a third day to come and wait, with no guarantee of being served yet again!


Yes people, this is how we are treated in our own country by our 'civil service' that in many instances lacks civility (training in politeness and courtesy) – and we, stupid people that we can be, allow our own people to treat us with this 'too bad too sad, lack of apology, no-caring attitude!'

After much disgruntled dialogue back and forth from those 15 or so of us who had been so unceremoniously left in the lurch, we were assured that we would be put at the top of the list for the following day. The final statement made by a high ranking office member as they turned away from us - the citizens they are hired to serve and whose money pays their salary - was 'you can only do so much'.

Well, I beg to differ, as evidenced with the writing of this open letter to the public in the hopes that so much more can indeed be done by us -civil society - providing constructive criticism to you - the civil servants and your bosses - that will hopefully result in a mutually beneficial win-win for us all – the Bahamian people and our country. Citizens should not have to leave 'gubment' offices annoyed and frustrated – we should leave pleased and satisfied for having been afforded the excellent customer service we deserve from government personnel that are proud to provide it in an efficient and courteous manner.

E D I T O R I A L It's The Economy, Stupid

"It's the economy, stupid is a slight variation of the phrase "The economy, Stupid, which James Carville had coined as a campaign strategist of Bill Clinton's successful 1992 presidential campaign against sitting President the late George H.W. Bush.

Carville's original phrase was meant for the internal audience of Clinton's campaign workers as one of the three messages to focus on the other two messages being "Change versus more of the same" and "Don't forget health care."

Clinton's campaign advantageously used the prevailing recession in the United States as one of the campaign's means to successfully unseat President Bush in 1991.

In our country, the Bahamas, the main issue has been the economy for many years. According to the International Monetary Fund, the economy of the Bahamas has not grown in almost two decades. While some politicians point to the growth of one or two per cent of the Gross National Product (GDP), in some of those years since 2000, the Bahamas has been experiencing structural unemployment and an increased number of discouraged workers for many years.

Women in particular who are now in their late forties and early fifties have not been gainfully employed for many years and have become more and more dependent on family members and friends for their survival. What compounds the issue is the fact that some 5,000 young Bahamians who graduate from High Schools and Colleges enter the job market on an annual basis. The Bahamian economy is simply not producing jobs at the rate it should to decrease the level of unemployment that has averaged 10 per cent or more for the last decade. In The House of Assembly last Wednesday, the Minister of Finance Peter Turnquest said, "when we look at the latest unemployment figures, we see that there is clearly a lag between the growth of the labour force and the growth of new jobs. This simply means that the economy is not growing quickly enough to absorb the new entrants into the job market.

"The transformative, socio-economic growth agenda of this administration is vitally critical to driving a turnaround in the key indicators such as the unemployment rate. In realizing that, we have committed our efforts to providing an impetus to private sector growth via the support of small and medium-sized enterprises, as they account for the bulk of new job opportunities."

The fiscal policies of the Minnis administration have exacerbated the problems in the economy. Since coming to office in May of 2017, the new government has inflicted body blows to the economy. The major one was the increase in Value Added Tax (VAT) by 60 per cent. This has been the main source of distress and the government was warned against this increase by every economist in the country.

While the Minister of Finance believed that it would have assisted in increasing government revenue and reduce the national budget deficit, the increase caused many people to cut back on spending, thus causing a decline in government revenue. It has brought about economic stagnation or slowed the economy down considerably.

In the mid term budget communication, the Minister revealed that there has been a budget short-fall in the first six months of

What is being spotlighted here is a sad and dangerous deterioration of common courtesy and disregard for one another that used to be the hallmark of what 'true true community' meant.

Wake up and speak up, Bahamas – let's march upward and onward, together, to a common loftier goal!



During a ceremony Thursday, February 28, 2019 a total of 41 persons from Bain and Grants Town communities became the first set of Environmental Monitors after 12 weeks of intense training.

The ceremony was held at the Wesley Methodist Church hall on Meadow Street, during which Minister of the Environment and Housing the Hon. Romauld Ferreira delivered remarks on the initiative – a partnership between the Over-the Hill

Unit in the Office of the Prime Minister and the Department of Environmental Health Services.

This particular effort sees a partnership between The Over-the-Hill Initiative and the Ministry of the Environment & Housing, which last year introduced the #Be A Hero Campaign to recognize community leaders for going the extra mile.

Samita Ferguson, Executive Manager of the Over-the-Hill Unit in the Office of the Prime Minister underscored the importance of the partnership initiative. Also present at the graduation ceremony were the Members of Parliament for Centreville, and Bain and Grant's Town, Reece Chipman and Travis Robinson, respectively.

The Over-The-Hill Community Development Partnership Initiative is serious about its mandate to transform lives and bring rejuvenation to the Bain & Grants Town and Centerville communities according to Mrs. Ferguson.

The Environmental Monitors hail from the various communities within the Over-the-Hill area. Now that they have graduated, their responsibilities will vary from ensuring the areas are free from environmental infractions such as illegal dumping, monitoring target areas daily, filing weekly reports and presenting evidence that could lead to offenders being charged in a revived environmental court.

The ongoing cleanup campaign entails a fourpronged approach. Once the monitor identifies an abandoned vehicle or another hazard, a notice would be placed on it with a request for removal within a given timeframe.

Other aspects include a doubling of regular garbage collection with twice weekly pick-ups in the targeted areas; and the concern of abandoned, derelict buildings.

The Over-the-Hill Community Development Partnership Initiative, officially launched in May 2018, is built around six key pillars designed to fully restore the Over-theHill residential areas. The pillars are:

Social Empowerment; Economic Empowerment; Rejuvenation; Smart Technology; Green and Sustainable Technology; and Programmes for the Youth and the Elderly.

The Over-the-Hill Community Development Partnership Initiative is the brainchild of Prime Minister, the Most Hon. Dr. Hubert A Minnis, whose goal is to transform those communities into cleaner and safer environments, while economically empowering residents.




