In his third report, Prime Minister Minnis will update the public on matters related to land reform, the environment, energy reform, general infrastructure and digital transformation and modernization.


The report will highlight major reform efforts underway to digitize and modernize government services and the implementation of a system to clear the land application backlog and restructure the application process for Crown Land.


An overview of the extensive ongoing roadworks program throughout New Providence and

Mr. Davis said that the Finance Minister and his cabinet colleagues are "bloody minded" in their desire to abandon well considered plans for the modernization of the country left in place by the Christie Administration.

This, he said, is all in an effort to mortgage the assets of the State to benefit foreigners, friends, families, and political cronies.

Mr. Davis predicts this will intensify in the upcoming fiscal year.

He said, "they have decided to transfer public buildings to a fund created by Holowesko Partners to minimize the ability of other Bahamian individuals and entities such as the National Insurance Board, churches and ordinary Bahamians from renting to the Government. At an estimated \$400 million price tag, one can only imagine the windfall the Holowesko Partners stand to gain from compounded interest payments alone."

He also expressed that the government has decided to eliminate business license fees for all banks including RBC, Scotia, CIBC, Citibank and Commonwealth Bank as a reward for their profiteering of Bahamian workers and not lending to Bahamian businesses.

Additionally, he said that the current administration ensures that business license and Value Added Tax (VAT) is calculated on the same tax base to reduce the business license fees of large food stores, pharmacies, Morton Salt and others with large zero-rated or exempt supplies.

Lastly, he said that the government's decision to join the World Trade Organization and reduce the Common External Tariffs (CEF) to an average of 15 per cent in less than three years, will benefit large importers and in the process, foregoing more that \$100 million in revenue without any articulated replacement

While statistics shows a 1.6 per cent growth in the economy, Mr. Davis noted that customs revenue is down in comparison to last year at the end of the third quarter.

Overall, he said, the government's revenue is also down against projections at the end of the third quarter because of what he calls an "ill -considered 60 per cent increase in VAT and meddling with the tax structure of the web shop gaming industry."

Additionally, the opposition leader labelled the dismantling of the Revenue Enhancement Unit within the Ministry of Finance as another "poor politically motivated policy".

He added that there was over \$400 million in uncollected taxes and hundreds of high end properties unregistered, leaving taxes unpaid.

The PLP leader said,

"As this Government is both arrogant and indifferent to human suffering, all of these institutions have been forced to do more with less and the non-Governmental Organizations which in the past have relied on Government subvention, now do so virtually alone as a result of no adjustment in their subvention to account for the 60 per cent increase in VAT imposed last year."

For the working poor, Mr. Davis said, the outlook is bleak, as he indicated that the government refuses to increase minimum wage in the wake of raising taxes.

He added that VAT's increase coupled with significantly inflation reduced the poor's small income.

As a result, he said, the government has five options – to increase taxes and/ or fees, drastically cut recurrent and capital expenditure, borrow from the Central Bank, borrow internationally, or find any excuse to abandon the government's failed policies... all of which he says are equally bad for the country.

"In light of the foregoing, we in the PLP have no confidence in the ability of this FNM government to put politics aside and bring to Parliament a realistic and practical budget, taking into account the reality of what is happening on the ground and literally in thousands of Bahamian households.", he said

"We say again that the country would have been better off and better served had the FNM left in place many of the policies they inherited from the PLP government.", he added.

Finance Minister Peter Turnquest is set to give his third budget communication of this term on or before Wednesday may

pects in connection with the most recent homicide here in the capital.

He said, "Officers executed a search warrant on the property. Once they entered the property, they were confronted by two armed suspects opening fire on the officers.

"The officers being in fear for their life, returned fire. Both suspects were shot and certainly injured. Officered then proceeded to empty out the building."

Superintendent Cash indicated that as they continued into the building,

they were confronted by a third suspect.

He was also shot as officers were in fear for their lives, according to Chief Superintendent Cash, who said, once the gunfire subsided, officers recovered three firearms.

However, he revealed to The Journal later that day that a total of five firearms were recovered from the property along with 22 pounds of marijuana.

When questioned, he declined to comment on reports that children were used as human shields.

Officer Cash did however confirm that all per-

sons in the Newgate Road two story home were taken into custody.

Sources claiming to be close to the victims, told The Journal that their loved ones were actually unarmed and that while the suspects are known to police, authorities clearly came to the home with the intention to kill.

In fact, one resident of the home alleges that an officer expressed such intentions shortly after arriving on the property.

At last report, residents of that home are still in police custody; the number however, was not specified.

Radio Programme Jones and Company, the Senator said, "we still have baby boomers leading the millennial generation, and how can you connect to us if you do not have millennials as a part of your team?

"If you look at how this government has set up their Cabinet, they had young persons that ran. They had young persons that were selected to represent various constituencies, but those persons did not get a seat at the actual table where the actual decisions are being made," she added.

Mrs. Coleby-Davis said that this is important with regard to determining which direction the country should go.

"They would be able to tell them, wait. Instead of trying to sign off another hotel deal, millennials actually want to be entrepreneurs. So, how about we bring some industries in here, and try to find more ways to build more young entrepreneurs in The Bahamas."

The PLP senator said that the only way to patch this disconnect is to actually give millennials an opportunity to sit at the table and make decisions.

"when She said, Pindling was in power, he represented a generation of women wanting to vote, men wanting to vote, but didn't own land, persons that wanted to work in the banks and didn't want to just be housekeepers, and the taxi cab generation.

statistical reduction in certain crimes, particularly homicides, then only days later, there are multiple slayings. The criminal is hardly impressed or frightened by statistics. In fact, some persons are so demonic and depraved that the recent announcement of relatively positive crime statistics might have motivated some with criminal intent," he said.

The Cleric said, "both the ghastly act of rape and the nefarious, intentional murder of a human being qualifies as the worst of the worst in my book – the United Kingdom's Privy Council's position notwithstanding.

"We are too passive in this country for certain matters and we must not accept wanton acts of crime as our new normal. Anyone rightly convicted through the judicial system of rape and/or murder should be removed from civilized society for the rest of his or her natural life.

"I do believe that when people make mistakes, particularly when they are repentant, they deserve another chance to remake their lives," said Bishop

"Unfortunately, I am also convinced that there are some who are impervious to the best that society offers, and they should be permanently removed from civilization.

"A life sentence without parole protects public safety, while sparing the barbarity of killing our It sends the strongest message that violent acts will be severely punished." Bishop Hall said.

establishment of a national Sea Park at Clifton.



COUNTER – CULTURES AND CRIME

Public attention in The Bahamas is again being focused on what appears to be a contagion of crimes against persons and property. In a number of particularly gruesome instances, allegations are made of grotesquely savage attacks upon a number of victims. In a number of cases, savagery was sexualized, with girls and women being subjected to no end of terror.

In addition, there is an increase in the number of extra-judicial homicides in the Bahamas. Just last Friday, Police killed three men in a home on the Eastern Road in New Providence who they say were wanted after committing murder.

For a time, this onslaught of crime news had the pernicious side effect of fuelling an outbreak of fear and dread which threatened to unleash an avalanche of hysteria. Many householders started to believe that they were defencseless, and that the police were being stymied by their nemeses in the criminal underworld.

Many residents who support the Police now say, they have apparently risen to the challenge implicit in the threat to their credibility and the mental composure of the public. With the arrest of a number of alleged law breakers, a number of Bahamians are just now daring to breathe a little freer. So while we have no way of knowing for a fact that the people accused are guilty of committing any offence against anyone, we, are quite pleased and comforted that our Policemen are determined to bring serious crime under control, which have led to charges being laid against a number of people.

Time will tell whether the people who are held can help bring closure to the recent spate of homicides, robberies, rapes and kidnappings in New Providence, Grand Bahama and the rest of The Bahamas.

Believing as we do in the supremacy of the law in The Bahamas, we counsel that now that the police have suspects in their protective custody, all efforts much be made of afford these Bahamians the respectful care and attention they deserve. The quintessence of the matter is that no matter what the charge, no matter what the public outrage or fear, there is the magisterial principle of the presumption of innocence which demands that those bringing accusations prove their

We allude to this principle because many Bahamians – in their innocence, ignorance or naivete - often rush to judgement and conclude that once a person has been charged, guilt has been affirmed and confirmed.

In extreme cases, enraged mobs take the law into their hands and execute their own brutal brand of rough justice. Such mobs are themselves guilty of undermining law and order. This is why we are adamant in our conclusion that the police should never shirk from their duty when faced with crowds which threaten public order and decency.

Fortunately for the entire nation, the Royal Bahamas Police Force has carried out its duties with consummate professionalism. The result has been that police officers are able to carry out their duty to serve and protect not only the public, but also the citizens who are in their custody.

Now, lest we be considered naïve, we hasten to add that there are instances where police do exceed their powers, thereby becoming law breakers themselves. When this happens, the law - again - should take its course, without fear or favour

While we are relieved by the new developments which have come to light concerning a number of crimes against persons and property and what the police have achieved, we are alarmed by what appears to be a growing counterculture, one which apparently condones, encourages and legitimizes horror attacks upon innocent men, women and chil-

Evidence of the existence of this counter culture is to be found throughout any number of neighbourhoods in our urban spaces where neighbours, family and friends routinely cloak their rapacious sons and daughters and shield them from the state sanctioned consequences of their actions.

This 'cloaking' begins when parents find out that their children are using drugs or alcohol. It begins when they become aware that their under age children are sexually active. It is full-blown when these parents decide to do nothing about their children's offences. A similar pattern is revealed in school when teachers routinely cover up the criminal behaviours of their peers and their student charges. Indeed, the Ministry of Education itself becomes complicit in cloaking when it denies media and police direct access to school campuses. Cloaking takes place whenever information is massaged and managed. Unfortunately - and often tragically many Bahamians cloak, shield and deny until

When they reach the point where dereliction and delinquency can no longer be denied, they often turn their wrath on any number of scarpegoats. The truth, however, is extremely simple: when mainstream society fails, counter-cultures proliferate. The Bahamas is uniquely susceptible to assault from any number of negative cultural influences which would work to corrupt and pollute the nation. As we have previously argued, the government and its social partners must move with all due speed to shore up the foundation institutions undergirding this nation, inclusive of family, school and church. Continuing neglect can and will lead to further ruin, more rot, community disintegration and the proliferation of criminal counter-cultures.
