### MINNIS HAS PRODUCTIVE TALKS WITH U.S. INVESTMENT CORPORATION

Prime Minister the Most. Hon. Dr. Hubert Minnis held productive discussions with senior officials of the Overseas Private Investment Corporation (OPIC) and the United States Embassy at the Office of the Prime Minister on Monday, 20 May

The visit by OPIC is a follow through to a meeting between United States President Donald J. Trump and a group of Caribbean leaders in March 2019, when a greater role for OPIC in the region was discussed, and the President commit-

ted to foster economic growth and strengthen security cooperation in the Caribbean.

"We are encouraged by these talks and the possible opportunities it may present for The Bahamas, particularly in the areas of energy and entrepreneurship," said Prime Minister Minnis.

OPIC has expressed an interest in collaborating on energy development projects in The Bahamas and providing grants and/or loans for micro and small businesses, particularly for women entrepreneurs.

The corporation is interested in supporting projects related to Family Islands power generation using non-oil sources, including solar, and using LNG to produce power in the Family Islands.

OPIC is a self-sustaining US government agency that helps businesses invest in emerging markets, with an emphasis on developing countries.

The corporation's projects in the region include small business lending, power generation, agriculture and low-income mortgage lending,

tourism, affordable housing, impact investing, financial services and infrastructure.

While in The Bahamas, OPIC officials also met with senior government officials and executives of Bahamas Power and Light (BPL) and the Bahamas Chamber of Commerce and Employers Federation.

Historically, OPIC has

provided over \$19 million in assistance for a number of agriculture projects, government single family housing construction, a ship launch and entertainment facility and the purchase and refurbishment of a chemical company.

The OPIC delegation included David Bohigian, Acting President and CEO; Deaver Alexander, Senior Advisor, Managing Director for Energy; Cari Lutkins, Director for Strategic Initiatives; Amanda Burke, Deputy Vice-President for External Affairs; Kristie Pellecchia, Managing Director of the Western Hemisphere; and Brian O'Hanlon, Managing Director for Business Development, Structured Finance and Insurance.

### PRISON FELLOWSHIP TO HOST CARIBBEAN FELLOWSHIPS

Prison Fellowship Bahamas (PFB) will host the 3rd annual Regional Conference of Prison Fellowship International in New Providence, anticipating fellowship partners from 12 Caribbean countries, for a week long seminar.

Under the theme Caribbean United in Faith, Breaking Shackles and Changing Lives, former Regional Director for the Caribbean for Prison Fellowship International, **Programs** Coordinator for PFB, David Williams, said Prison Fellowship ministries will come from as far as Jamaica, Barbados, Bermuda Antigua and Barbuda and the Cayman Islands.

"The broad goals of the conference are fellowship, education and training, and initiative sharing.

"Highlight presentations will cover reports from the various countries, strategies for capacity building for longevity, fund raising - the new paradigm, protocols of prison ministry, and Prison International's signature programs, TPJ and Sycamore Tree.

"We will also be addressing child molestation, rape prevention and prevention of gender based violence, considering the time we live in, particularly in The Bahamas," Mr. Williams said.

As More than 100 evangelism workers, from churches across The Bahamas, have been invited to join the PFB in this conference, Mr. Williams says it's a great opportunity for the public to get involved in ministry.

"Prison ministry is one of the purest forms of the love of God in the midst of broken humanity, and we invite the benevolent, sensitive, and the financially generous citizens among us to jump in and help us to plan and put on a very successful conference.

"As we all lend a hand in aiding the fallen in our land to walk again, we must remember that Jesus says if you have done it unto the least of these, you have done it unto me," Mr. Williams said.



### Dames: Neighbourhood Watch Groups **Pivotal to Success of Communities**

The Minister of National Security, Marvin Dames along with members of National Neighbourhood Watch Council (NNWC), neighbourhood watch group leaders and members, and police liaisons attended the Neighborhoods USA (NUSA) Conference, May 15th – 18th, 2019 in Palm Springs California.

The purpose of the conference was to bring together neighbourhood groups from throughout the United States and other parts of the world to share best practices as they related to community residents, law enforcement and other community partners with the intent to foster safer communi-

For The Bahamas, specifically, the Blair Citizens' Association is the first known neighbourhood watch group, formed in 1975. Since then many more neighbourhood groups have followed; however, the groups lacked standardization and existed in silos.

Since coming to office in 2017, Minister Dames envisioned and has facilitated the development of more comprehensive and purposeful neighoubrhood watch groups. In accordance, in July 2018 National Neighbourhood Watch Council was launched. The Council serves as the overarching body to coordinate activities among the respective groups throughout The Bahamas. The new and progressive initiative seeks to encourage and assist communities wishing to form neighbourhood watch

Despite its short existence, there are now 112 neighbourhood watch groups, of which 90 are in New Providence, 16 in Grand Bahama, and 6 in Abaco. For the first time police liaisons were introduced and they serve to provide a direct link and partnership in the fight against crime. The liaisons also serve to provide training, guidance and support for their respective groups.

Minister Dames and representatives from The Bahamas aimed to garner and share best practices with NUSA's presenters, strategists, practitioners and citizens. There were over 700 delegates from throughout the United States and The Bahamas had the largest international delegation in attendance. The objective for the Bahamian delegation was to gain extensive knowledge on how the Ministry of National Security, NNWC, law enforcement and con-

cerned citizens could build stronger communities in The Bahamas.

Another purpose of the neighbourhood watch groups was to inspire young people, especially young Neighbourhood watch groups are not only concerned with fighting crime but on building stronger communities through partnerships. Of the 21 persons who travelled to the conference, Mr. Watson Castin was the youngest member of the group and one of the youngest to join his neighbourhood community group.

He resides in the Bain and Grant's Town Constituency and instead of allowing the challenges of being in a community with a high propensity for crime decide his life choices, he has chosen to live a crime and drug free life. The conference in Palm Springs represented many first for Mr. Castin as this was his first time travelling internationally. While most Bahamians' first international trip is usually to Florida, Mr. Castin's was sunny California. For him, through the trip, he hoped to increase his knowledge base to develop into a responsible contributing member of society. He hopes one day to become a member of the Royal Bahamas Police Force.

During the opening ceremony, Mr. Dames acknowledged that the respective neighbourhood watch groups are pivotal to the success and development of communities, and that the present challenges did not mushroom overnight but festered due to neglect. He posited that community residents should work together to devise grassroot strategies to foster neighbourhoods that reflect their distinct values and beliefs: It is only through the individual efforts of each neighbourhood watch group that collectively countries will be able to enjoy safe places to live, work and prosper.

The NNWC of The Bahamas will travel to Exuma and Eleuthera to introduce the concept of neighbourhood watch groups. This will be followed by committee members of the NNWC, law enforcement, neghbourhood watch groups, corporate Bahamas and community activists preparing for Bahamas' first neighborhood watch conference which is scheduled for October. The conference hopes to expand the work of the Council and respective groups.

road network capacity, which will result in the reduction of delays along this congested corridor during heavy peak traffic hours.

"The government will be seeking proposals from local consultants for the design and supervision of Tonique Williams-Darling Highway, between Bethel Avenue and John F. Kennedy Drive. The four lane highway will continue between Bethel Avenue and JFK Drive, and Baillou Hill Road between Solider Road and Cowpen Road.", he added.

The Prime Minister added that the government plans to improve the section of road between Soldier Road and Carmichael Road by increasing the number of south-bound lanes and by widening the section of Baillou Hill road to Cowpen Road from two lanes to four lanes.

Dr. Minnis said, "We will continue with

increasing the northsouth road network capacity by extending the existing Milo Butler Highway southwards from Carmichael Road to Cowpen Road.

"The proposed project will comprise a four lane dual carriage way together with roundabout junctions, street lighting, drainage, sidewalks, traffic signs, road markings, and landscaping.", he added.

A design for the improvement of Coconut Grove between Baillou

Hill Road and East Street is also underway, according to the Prime Minister.

Additionally, the development of new junction improvements are also set to begin with the installation of new traffic signals and road widening at C o m m o n w e a l t h Boulevard and Prince Charles Drive along with Arawak Cay and West Bay Street.

There is also improvements slated for the injunction of West Bay Street and Blake Road where a new roundabout is expected to develop.

Dr. Minnis added that the resurfacing and rehabilitation for Village Road is also underway from Village Lane to Shirley Street, and a number of sidewalks have also been installed throughout various communities in New Providence.

This, he said, is a part of the government's initiative to heighten pedestrian safety.

The Prime Minister said, the government is

planning the establishment of a Traffic Management Center in order to monitor all signals remotely in an effort to improve response times to any technical issues which require attention."

This traffic management center will also observe changes in the traffic flow pattern and/ or volumes, adjust signal timings, to optimize the performance of a junction or signalize the corridor, and collect daily traffic data

Minister Dion Foulkes, the parade is completely in the hands of the trade union congress and is confident that they will advise him on the changes soon.

"I think that they have given serious consideration to it. I anticipate, in sufficient time for parade, that they will advise," he said.

At the parade last year a runaway truck hit participants in the area of East and Shirley Streets killing four and injuring 20.

The victims- Dianne Elizabeth Ferguson, 55; Kathleen Augusta Fernander, 51; Tabitha Charlene Haye, 41 and Tami Patrice Gibson, 48.

At that time Prime Minister Dr. Hubert Minnis described the incident as a tragedy.

In September 22 year old Travis Sawyer was charged before Deputy Chief Magistrate Subusola Swain with four counts of manslaughter by negligence.

Last month Trade Union Congress General Secretary Tyrone 'Rock' Morris told reporters that no major changes was made to the upcoming parade.

Following his comments, Minister Foulkes said he would intervene on the matter and advice trade unionist to make the needed changes.

The presentation by Rights Bahamas (RB) and Robert F Kennedy Human Rights the Inter-American to Human Rights Commission on (Commission) in Jamaica on May 12 was unfortunately not reported in context by the local media except for The Tribune, the only organisation that bothered to send a journalist to this important international hearing and cover what actually happened.

Reporting by other media houses was based on selective extraction of content from the government's presentation and the Commissioner's comments. This resulted in an erroneous perception the RB presented a malicious, untrue and damaging report about the conditions of migrants in The Bahamas for the purpose of intentionally harming the country's international reputation. Nothing could be further from the truth. In fact the very opposite occurred.

RB was allotted 15 minutes and within that time, Stephanie St Fleur, President; Louby Georges, International Affairs Director; and Dawrin Thompson, Education Committee Chairman presented. They spoke against the backdrop of a video showing a half naked woman being abused by Immigration officers, as well as a series of photographs showing migrants and their treatment in The Bahamas. RB Vice President Joseph Darville and Legal Director Fred Smith were part of the delegation, but were not slated to present.


The government's presentation, by Minister of Legal Affairs Elsworth Johnson, was not a response to RB as was called for, but rather a litany of defences for anticipated attacks by RB and technical objections to the jurisdiction of the Commission.

In addition, Minister Johnson presented to the Commission and repeatedly referred to a booklet entitled Know Your Rights, printed 18 months ago by RB. He complained the booklet misrepresented the facts, as some of the photos were not taken in The Bahamas.

This is misleading. The booklet was not intended, nor does it claim to be a historical record of incidents that occurred in The Bahamas. It is a compendium in Spanish, Creole and English, in which people's rights are explained with photos dramatising events. The booklet contains photographs from The Bahamas, South Africa, the United States and elsewhere which are for illustrative purposes regarding whichever relevant "right" is being explained in each instance.

RB stands by the booklet and its contents. But we emphasise for the record that the booklet was presented by the government to the Commission, NOT by RB. For their part, the Commissioners seemed not at all moved by the repeated references to the photos, and they did notquestion RB about any aspect of its presentation or conduct in general, as they did the government. Minister Johnson took no issue with the video and photos in the RB power point presentation.

After the government's presentation, various Commissioners expressed views on a number of matters such as the ongoing use of detention contrary to international trends and Inter-American standards; statelessness; the right of children to education; and gender equality. These views have resulted from the



Commissioner's independent investigations and their own knowledge, and they requested the government to address these issues.

It is important to note this is the second hearing in a continuing investigation started in 2015 when the Commission requested The Bahamas ameliorate and mitigate the harsh challenges facing migrants. The government sought to defend the perceived criticism by the Commissioners of The Bahamas. The Commissioners reminded the government this was not an adversarial forum and it was their intention to urge constructive dialogues and cooperation between the Commission, the government and civil society.

To this end the Commission accepted The Bahamas' invitation for the Commission to conduct an on-site visit to the Carmichael Road Detention Centre. In this continuing spirit of cooperation, I was then given a five-minute opportunity to respond by the Commissioners.

In summary, I congratulated the current administration for its efforts in preventing sex tourism and human trafficking (a matter which had been raised by one of the Commissioners); acknowledged the current administration as more enlightened than its predecessors; emphasised RB's commitment to cooperate; implored the government to distinguish between illegal migrants and those born in The Bahamas who are entitled to status; begged for an avoidance of unnecessary detention; and, referring to an historical paroling of Cubans into the community, suggested many migrants could be permitted to work instead of being detained, rather than continuing to be a financial burden on The Bahamas. (After all, decades of research have shown that migrant workers, do not 'take' jobs from local workers, and boost rather than harm the host economy generally.)

I also asked Minister Johnson to allow RB and other human rights organisations to visit the Detention Centre with the Commission and ended by urging The Bahamas, as part of the global community, to end its fear of foreigners and welcome them to help develop the country which, although it has a small population, is geographically large.

Johnson responded for the government but once again focused on the photographs in the booklet and, to the obvious consternation of the Commissioners, dramatically rejected by saying "never", to RB joining the Commission on its visit to the Detention Centre. Clearly as a result of the continued defence of the indefensible by The

### PREVENTION OF NCDS

For the next three months, The Jones Communications Network in conjunction with the Ministry of Health and other social partners will place special emphasis in the prevention of non-communicable diseases in the Bahamas.

These diseases are destroying our way of life and are having a negative impact on the level of productivity in the country. It is said that NCDs are largely the result of urbanization and bad eating habits. Our health-care facilities are severely challenged and the system makes it extremely expensive for most Bahamians who seek care for diseases such as diabetes, hypertension, Renal failure and various forms of cancers, among other things.

There is a national urgency to address this epidemic which is wreaking havoc and leading to fatalities around the Bahamas.

As a society, we must concentrate in teaching young Bahamians the importance of maintaining a good diet and to be tested yearly by a physician. There are tens of thousands of young Bahamians who run a gauntlet of greasy food joints, and little old ladies selling all manner of sugary stuff out of the back trunks of their vehicles.

The consumption of their stuff is – to say the least – the purest bad news. In time, these children will suffer. And in time, some of these children will become obese. Others will fall victim to other diseases that will afflict them in mind and body.

This is the price they and their parents will pay for their ignorance.

We are convinced that none of this need be the case in this day and age. Information about what children and adults should be eating is widely available.

Officials in the Ministries of Education and Health are fully aware of what should be done to put this nation's children on the right path to good health. This is why the radio and television shows and promos by JCN are essential.

Tragically, no one is doing near enough to nip in the bud certain nutrition-related problems in this nation's youthful population. This explains the problems some of our older citizens now face.

Many of their ills and diseases are now lumped together under the rubric 'life-style related' ailments.

Most of these ailments can be traced back to those times and places where children were exposed to greasy foods, sugary concoctions and other junk, some of it replacing real food.

Sadly, as more and more Bahamians get

into the fast lane, they are led to believe that they should consume fast foods. The result is soon apparent, which is that they come down with a litany of diseases that are today prevalent in the United States of America, that land to the north where everything seems speed up.

This is no way to live. Indeed, this is a sure road to disease and death.

We note that some of this nation's youngsters often have to make do with some version or the other of the new ubiquitous 99 cent breakfast. But no matter, what they do as they try to feed themselves-on the run, so to speak - these children will suffer. In our considered opinion, these children are being set up for failure.

We have it on very good authority that the first meal of the day – literally, the break-fast is the meal that sets the pace for the day ahead. It therefore does not surprise us at all that so very many of our children are wallowing in obesity.

There are connections between what our children eat, how they grow, how they think, how they learn and how they behave.

We are also convinced that the time has come for the authorities to take a closer look at this problem with a view towards finding solutions to what we take to be a major national problem.

It does not take a genius or a rocket scientist to figure out that it would be good for everyone if our youthful population was better fed.

It might make some sense for these children to be fed at school and for each school to be provided with an adequate cafeteria. Were we to go down that road, our nation's children could be guaranteed fruit, vegetables, bread and other food items deemed essential.

The authorities should begin to act as if the health of the nation was actually the wealth of the nation. And then, they would begin to see the connection between education and health.

This once beloved land of ours is today afloat in a quagmire of moral contradic-

One of these contradictions witnesses the situation where children who are on the road to school are so malnourished that when they do arrive, the school experience is vitiated.

This need not be the case. We can begin to see the vital connection between the health of the Bahamian nation and the waste of the wealth of this land of ours in the junk food we allow this nation's youth to eat.

Mr. Mitchell said, "we have to always, as citizens of The Bahamas, and Government Opposition, keep our rational minds when dealing with all of our public policy matters. And not go off behind dog whistles, racism and xenophobia. When you look at the report, it is filled with all of those things.

"The interesting thing is One America has twisted these facts to together in this report, which makes it seem as if the hordes from the Far East are coming to take over The Bahamas, is simply inaccurate, and as I said, if we keep our rational minds, we'd say they are not true."

"The Port, for example, about which they speak, is a port which is funded by an interest in Hong Kong, which is a special Administrative Section of the People's Republic of

China, and is owned by private individuals. That investment has been quite a successful investment for Freeport. There are differences of opinion on whether or not we are getting as much as we should get from it, but that is a private investment, that's not a Chinese, as in Government Chinese investment.

"The interesting thing about the comment they make about Baha Mar, is that Baha Mar, although the ultimate beneficial owner is a private citizen,

he's also a private investor who runs and controls Baha Mar, and the company, if I'm not mistaken, is an American company, which that investor owns, so if the Americans can allow the Chinese to own an American company, what then is the issue with the Commonwealth of The Bahamas?" Senator Mitchell asked.

The United States and China are embroiled in a Trade War with every indication pointing that it will be a long war.
