# Gredit Ratin Morries Gov't

## USAID DONATES ADDITIONAL \$7.5 MILLION FOR HUMANITARIAN ASSISTANCE IN GRAND BAHAMA

The United States is providing an additional \$7.5 million dollars in humanitarian assistance to the people of The Bahamas who were affected by Hurricane Dorian, bringing the United States' total funding for the response to Dorian to more than \$33 million.

The additional funding was announced by the United States Agency for International Development (USAID) Administrator Green, during a press briefing at Samaritan's Purse on Tuesday,

# Older Persons Bill Being Drafted

New legislation is expected to be drafted to ensure that older persons receive equality.

The Ministry of Social Services and Urban Development have taken its first steps to drafting the Older Persons Bill, which according to Governor General CA Smith, will codify rights long denied to older persons, thereby bringing The Bahamas in line with United Nations principles of older persons.

The governor general told an audience of young and old, during the thanksgiving service to kick off Older Persons Month, that one of those rights is the right to independence.

"That is having an income sufficient to ensure that your basic needs for food, for shelter and for health care are met," Mr. Smith said.

"These rights will also include the right to participation. That is you ought to be given the opportunity to have a voice in decisions that affect you and allow you to contribute positively in your community affairs.

"These rights also include the right to care, to health care, proper institutional care, the care of the family and the protection from abuse."

Mr. Smith added that these rights also include that of self-fulfillment and the right to dignity.

The governor general also told the seniors that treatment must be the same for all and that there must be a commitment to ensuring this equality.

"We must commit to bringing attention to the fact that old age inequality does exist in our country. We must commit to recognizing the urgency for dealing with existing

inequalities so that future old age inequalities can be prevented," Mr. Smith said.

"We must commit to reviewing changes that need to be made that would level the playing field for all citizens. And we must commit to reflecting how best to change negative stereotypes of old age and eliminate the old age inequality."

Passionate about older persons, former Speaker of the House of Assembly, Italia Johnson, chairperson of the National Council on Older Persons, remarked that she is pained by the treatment of older persons and welcomed the drafting of the Older Persons Bill which she says will eliminate seniors not being afforded their full rights.

"It [the bill] will ensure that your rights are addressed with penalties



attached for violating your rights," Mrs. Johnson said. "You have rights. We

live in a country of laws

and when those rights are violated, penalties will be imposed."

# Man Shot Dead on Highway

Police are investigating the circumstances surrounding a shooting incident which resulted in the death of a man on Monday.

stand, where he admitted that he paid Gibson more than \$25,000.

During cross examination, the court heard that in the case of one of his projects, Ash had to start paying his workers himself as the government was taking too long and the payments ranged from \$50 per day to \$75 per day.

Ash said he got so frustrated with the lack of payment that he went to the National Emergency Management Agency (NEMA) and met Jack Thompson around the third week of January 2017.

Thompson, he said, then directed him to meet with Deborah Bastian.

According to the witness, at this point, the government owed him anywhere between \$800,000 and \$1.5 million.

He said prior to this, he

had never met Bastian, adding that he met her and Gibson at Gibson's office. At the time, he explained he was owed money and needed to be paid.

Ash told the court that during the meeting, Bastian yelled out for him to tell Gibson he gave Mr. Rahming, the chief engineer at the Ministry of Works, some money.

Ash then admitted that he did pay Mr. Rahming money prior to the meeting.

Ash then said he didn't come to expose anyone, but at that point during the meeting, Gibson smiled, got up and said "y'all two talk" and left the room.

Following the 20minute conversation with Bastian, Ash said he called the bank to get \$20,000 and went home to get another \$20,000, then met Bastian at the parking lot of Commonwealth Bank

Oakes Field branch to give her the funds.

As a result of that meeting he said he received a cheque between January 17 and 19 for \$250,000.

He added that Bastian gave him the cheque at NEMA on Harold Road.

All together, Ash said \$200,000. gave Additionally, he said on a few occasions after paying Bastian, he saw Gibson and Bastian meeting in the then minister's car.

In January 2017, Ash said he started directly communicating with Gibson straight up to Election Day.

Sometimes, he said, Gibson told him he needed some shingles, which meant money and he paid

Ash said he paid Gibson \$25,000 on two occasions and \$10,000 on another three occasions.

The trial resumes today at 10 a.m.

The Speaker underscored the necessity for the nation to rise above the recent negative experience of Hurricane Dorian.



Green was a part of a bipartisan, government effort.

"This assistance is part of a whole of the United States' Government effort in partnership with the Bahamian Government, charitable organizations and the private sector to address the humanitarian needs of those affected by the strongest storm ever to hit The Bahamas," said Green.

"This is a bipartisan group. Republicans and D e m o c r a t s; Administration, members of Congress... we are all united in our support for our neighbour, The Bahamas."

Thanking USAID for their financial assistance on behalf of the Prime Minister of the Bahamas, President of the Bahamas Senate and Coordinator for the National Emergency Management Agency (NEMA), Senator Kay Forbes-Smith said the United States and The Bahamas have such a great partnership and relationship.

have to be concerned. We are trying to manage these things very actively to keep them in front of us to ensure that we are planning appropriately and responding as we see circumstances develop."

While a possible drop in the country's credit rating is a concern, Turnquest pointed out that the government believes the information reported by The Central Bank governor on Monday that the pace of investment throughout the islands not affected by the hurricane would continue to move forward.

"The investments in Grand Bahama continue to move forward and we had the signing last week and the hotel deal continues to be negotiated, so we continue to expect that to close," Turnquest said.

"The Abaco community itself, the investors are eager to get back and to start to do their cleanup work and to get back into operation. The local business community too, despite the rumours, is also very eager to get back and have the opportunity to start rebuilding their properties. So we anticipate that within a reasonable period of time, we would start to see the

rebirth and these businesses come back on stream."

The deputy prime minister ensured that the government is working with all its partners to ensure that responses are given to concerns and stories that The Bahamas is still open for business are disseminated.

"The level of investment and the destination, as a preferred investment destination, is still very attractive and again, we believe that we will have the best results we can doing the things that we can do to control the circumstance as it exists today," Turnquest said.

recovery efforts continu

recovery efforts continue. This week, the National Emergency Management Agency (NEMA) reported that 876 people, who were on the missing persons list, have been found and 3,481 evacuees are registered with the Department of Social Services.

NEMA also revealed that 424 persons remain missing following Hurricane Dorian.

Meanwhile, a team from NEMA discovered 62 Haitian nationals living at Mission Baptist Church, Sand Bank, Treasure Cay Abaco.

The group consists of 40 adult males, 20 adult females, a 5-year-old boy and a 4-year-old girl. They have been at the church since August 28, 2019.

They are being supported by the Red Cross, Samaritan's Purse, World Food Programme and other international partners. The Ministry of Health is providing med-

ical support as well.

Pastor Herbert

Edgecombe from Faith Walk Church of God in Cooper's Town, Abaco agreed to use his church as a shelter, as the hall previously used is now a distribution center.

According to NEMA, its team also visited Abaco Beach Resort to inquire about accommodations, but it was not possible due to a lack of running water.

NEMA added that the team was able to coordinate with the Water and Sewerage Corporation in Abaco to address the situation.


