

Farewell to Former MP

Family, friends, parliamentarians and officials gathered to pay their respects to former Cabinet Minister and businessman Tennyson Wells during his funeral at Christ Church Cathedral on Friday.

Prime Minister Dr. Hubert Minnis gave his condolences to Well's wife Stephanie, the bereaved family and Well's colleagues.

He remembered him not only as a "noted and capable" businessman, but a devoted politician and a "FNM warrior."

"Along with the founders and other freedom fighters in the Free National Movement, he demonstrated the courage and the tenacity to enter the arena and to fight for what he believed," Dr. Minnis said.

"He fought against victimization and other threats to our democracy. He played his role in the FNM's first election to office in 1992 and in the Bahamian renewal under FNM governments." Wells served as Member of Parliament for the Bamboo Town constituency.

Dr. Minnis considered Wells as a friend. He recalled Wells counselling and guiding him during their morning and

evening calls.

"We owe a debt of gratitude to individuals like Tennyson Wells, who

offer themselves for public duty and service," the prime minister added.

"Like other democracies, our party-based system requires loyalty, fortitude and political maturity by those who answer the call to service their fellow-citizens in government and politics. Tennyson answered this call. He sacrificed for what he believed.

"He did not just sit on the sideline and complain about what was wrong with The Bahamas. He made a contribution and had a distinguished career. May our departed brother rest in peace."

Father Harry Bain, rector of Christ Church Cathedral, noted in his sermon that Wells would bend over backwards for people, gave away his salary as Chairman of the Bahamas Agriculture and Marine Science Institute (BAMSI) and was an inspiration to his family and fellowmen.

"Tennyson left a legacy as he was God fearing, kind, generous, forgiving and encouraged each family member to continue to show love unity, kindness and lasting relationships," Father Bain said

"He was the kind of person who did not flirt his possessions. He often boasted about living off \$300 per week."

Wells was laid to rest at Woodlawn Gardens. He died on September 24 in his sleep at the age of 72.

Ministry of Finance to Implement **Public Financial Management Reform**

and Minister of Finance Hon. K. Turnquest said at the Ministry of Finance, the heart of Public Financial Management Reform is the development and adoption of robust information systems.

"We are in the full swing of implementing the project plan for this multifaceted reform initiative," DPM Turnquest explained at a forum held by the Ministry of Finance in conjunction with the Inter-American Development Bank at Baha Mar. October 10, 2019. The forum was held under the theme, 'The Power of Data for Transforming National Development.'

"One of the ultimate outcomes is the eventual

Management Information System (IFMIS) that standardizes and centralizes the financial management operations for all ministries, departments, agencies and state-owned enterprises."

He noted that if individuals could project themselves into the future, and envision how IFMIS will digitally collect realtime data for planning, analysis and reporting across government, we can foresee the improvements in accuracy and efficiency in reporting financial data, boosting transparency and ultimately resulting in fiscal savings for the government.

DPM Turnquest said combined with the phased

Customs clearance platform, Click2Clear, one can see that the future for data in this country is looking completely transformed.

He stated Click2Clear is completely modernizing the way Customs operates. "The online system is designed to deliver faster, more efficient and comprehensive Customs processing once fully implemented."

The DPM explained that this means end-to-end online Customs processing and tracking, automated entry checking, tighter controls and risk management to reduce corruption and fraud, more accountability to protect government revenue, more statistical information and data derived from artificial

used for effective policy making.

"From a fiscal point of view, I cannot overstate the potential loss of opportunity for even more robust economic growth when we do not have sufficient real-time data and data analytics on what is happening in our economy. Deputy Prime Minister and Minister of Finance the Hon. K. Peter Turnquest announced on Thursday, October 10, 2019, that \$10 million will be taken from the Dormant Fund to help restart the economies in Abaco Bahama.

The Deputy Prime Minister was speaking at a press conference at the Ministry to announce that the Access Accelerator, Business Small Centre Development (SBDC), through the Ministry of Finance and private financial partners, is offering government

guaranteed loans to micro, small and medium-sized (MSMEs) enterprises directly affected Hurricane Dorian.

He said, "Both Grand Bahama and Abaco represent some 18 per cent of overall Gross Domestic Product and so it is in our interest and

certainly significant for us to get them back and up and operating to as near normal as quickly as possible."

The \$10 million will facilitate grants, loan Bahama.

FNM, Cartwright said, Chipman would have not been elected to the House of Assembly.

Cartwright pointed out that in his two years as chairman of the FNM Centreville Constituency Association, he never had a substantive or impactful conversation Chipman over the needs of Centreville residents or the

"Despite Mr. Chipman's decision to choose advancing his political career over doing what is best for the people of the area he represents, the party's constituency association will continue to look after the interests the people Centreville."

Prime However, Minister Dr. Hubert Minnis is not focused on Chipman's resignation, as he said his focus is on rebuilding the country post Hurricane Dorian.

St. George's Senior High, Eight Mile Secondary and Beacon School.

Lloyd explained that school administrators, support staff and teachers will return to school on Wednesday and students will return on Thursday.

"Staff and students from schools in East Grand Bahama have been reassigned to schools in the Freeport area. If anyone from those schools is unaware of where he or she has been posted, please contact the District Education Office details," Lloyd said.

"Works are continuing at the Hugh Campbell Primary School, Genesis Academy, Maurice Moore and the Haven School."

Lloyd also announced that Hugh Campbell and Maurice Moore Primary are expected to reopen on October 21 and both staff and students would be expected to report to school on that day.

"The district superintendent will provide an update on both of these schools, as soon as he is able to do so, and we advise the public to listen carefully for his announcements in this regard," he said.

"I wish to reiterate that every school that we have scheduled for reopening is safe for occupancy.

I have been informed that donors have ensured all of our schools will be adequately supplied with

bottled water, so that all of our students will have access to safe drinking water. Please note that some repair works will continue on various campuses. However, these necessary works will not interfere with nor compromise the health and safely of anyone, nor will they in any way negatively impact daily operations."

Lloyd also assured that the Ministry of Education will dispatch mental health professionals to enable and support the mental and emotional wellbeing of students and staff.

"A team of psychologists and counsellors led by our Employee Assistance Programme (EAP) and Guidance and Counselling Unit will visit Grand Bahama during this week. They will conduct extensive, intensive and ongoing therapeutic sessions with various groups. Further details will be communicated via the District Education Office," the minister of education said.

Following the destruction left by Hurricane Dorian, Lloyd noted that the road to reopening schools in Grand Bahama was littered with many obstacles

"First, public utilities were compromised significantly. Amidst the destruction, there was no electricity, communication networks were fragile and the water supply was contaminated. Then there was the need to conduct proper assessments to determine

the scope and extent of repairs. This included, but was not limited to a massive cleanup of the affected schools, which involved, tearing out damaged walls and ceilings, carting away debris and affecting extensive mould remediation work," Lloyd said.

"Many came together to mobilize an impressive effort, particularly given the circumstances. I am pleased to report that for the most part, public utilities have also been restored to acceptable levels. Where there are still challenges, for example with potable water, alternative systems are being implemented with the provision of sufficient drinking water to all campuses that need them."

With regards to the provision of education in Abaco, Lloyd expressed that the Ministry of Education is pleased with the self-help efforts which permitted the unofficial opening of schools on the

"Students are receiving instruction from teachers and volunteers in the public schools at Crossing Rocks, Cherokee Sound, Sandy Point, Moore's Island, Fox Town and Green Turtle Cay," he said.

"It is planned that teachers and students living in the Cooper's Town area will meet at a site to be determined sometime this week. In total, we expect that in excess of 400 students will be receiving instruction by the end of this week."

BARBADOS PM WARNS OF MASS MIGRATION BACKLASH BECAUSE OF CLIMATE CRISIS

BRIDGETOWN, Barbados, Saturday October 5, 2019 (IPS) – Prime Minister of Barbados Mia Mottley says her patience is running thin, as she challenges the world to tackle the climate

She warned of a backlash of mass migration to the world's richest and biggest polluters, saying an influx of climate refugees can be expected in coming years as a consequence of failing to take action to stop climate change.

"The bottom line is that we are not here by accident. There is no traditional norm on the part of the world where I come from," Mottley tells IPS.

In September 2014, Small Island Developing States met in Apia, Samoa for the Third International Conference on SIDS and adopted the Small Island Developing States Accelerated Modalities of Action, also known as the SAMOA Pathway. It is a 10-year plan to address challenges faced by small

During last week's United Nations General Assembly (UNGA), the world body convened a one-day, high-level review of progress made in addressing SIDS' priorities in the first five years since implementation. According to the world leaders,

progress toward sustainable development in SIDS will require a major increase in investment. Foreign Affairs Minister of Belize

Wilfred Elrington says the mid-term review represents more than a simple reflection.

"It is a critical political moment, given the overwhelming challenges that threaten our sustainable development," Elrington tells IPS.

"Our people receive daily reminders of the ticking clock for our survival. Last year we had a special report from the IPCC [Intergovernmental Panel on Climate Change] that predicted utter devastation for our countries if we missed the 1.5° C target."

Elrington says the latest special report on the ocean and cryosphere from the IPCC projecting that 65 million people who inhabit islands and low-lying states are at risk of total inundation, only reinforced what is already happening.

"Our beaches are disappearing, our drinking water is being salinated, our oceans and seas are warming, acidifying and deoxygenating threatening our reefs and our fisheries. And if we are not experiencing more frequent flooding events, we are experiencing extreme drought events," Elrington

"Anyone of us could be the next to face a Category 5 hurricane or cyclone. We are the ground zero of a global climate and biodiversity crisis."

Some of the specific development issues SIDS are faced with include their remoteness, transport connectivity, the small scale of their economies, the high cost of importing, the high cost of infrastructural development, vulnerability and climate vulnerability.

Already on the frontlines of climate change, sustainable development in many SIDS is threatened by difficulties in achieving sustained high levels of economic growth, owing in part to their vulnerabilities to the ongoing negative impacts of environmental challenges and external economic and financial shocks.

"It is diabolical and it is unbelievable. I refer to the plight of Barbuda whose cost of recovery was 10 times that which was pledged, and who still have not collected even that which was pledged," Mottley says.

"I refer to Dominica, whose public service is minuscule to most countries but who are required to jump through the same hoops to unlock 300 million dollars in public funds while the people of Dominica, who were affected like the people of Abaco and Grand Bahama [in the Bahamas], don't know where they're going to earn money this week."

The prime minister says: "Twenty five years ago we met in Barbados and settle the Barbados Programme of Action, and on that occasion, we recognised that the wellbeing and welfare of Small Islands Developing States required special recognition and was a special case for our environment and our development."

Meanwhile, Guyana's Minister of Foreign Affairs Karen Cummings says even with their limited resources, SIDS have been doing their part, adding that her country has taken an "aggressive" approach towards climate change and has been "ambitious" in its nationally determined contribution commitments.

Leaders called on the international community to mobilise additional development finance from all sources and at all levels to support SIDS and welcomed the ownership, leadership and efforts demonstrated by these states in advancing the Implementation of the SAMOA Pathway.

They expressed their concern about the devastating impacts of climate change, the increasing frequency, scale and intensity of disasters and called for urgent and ambitious global action in line with the Paris Agreement to address these threats and their impacts.

The High-level Review of the SAMOA Pathway comes one month after Hurricane Dorian devastated parts of the Bahamas, causing significant loss of life and property damage. Countries noted that the increasing frequency, scale and intensity of natural disasters will continue to claim lives. decimate infrastructure and remain a threat to food security.

While some progress has been made in addressing social inclusion, poverty, and unemployment, inequality continues to disproportionately affect vulnerable groups, including women and girls, persons with disabilities, children and youth. More support is needed to strengthen public health systems in SIDS and especially reduce the risk factors for non-communicable diseases, and healthcare after disasters.

Other areas identified as needing more effort include demographic data collection, trade opportunities, and economic growth and diversification.

Michael Tierney, Deputy Permanent Representative of Ireland to the United Nations and co-facilitator for the Political Declaration of the SAMOA Pathway midterm review, says SIDS have done excellent work in setting up a partnership framework at the United Nations, whereby the partnerships they are working on are monitored and registered and there is an analysis done of their effectiveness.

"It's actually a model of other parts of the world to look at. It can be improved and it can be strengthened but there is a very detailed process here at the U.N. whereby we try to encourage new development partnerships for the islands, but also, we try to monitor and analyse what we're doing and if we're doing it well," Tierney tells IPS.

"One of the things, quite frankly, that we need to do better is get more private sector interest in projects. That's a problem across the board in the developing world but it's something that is specifically a difficulty in the Small Island Developing States."

THE TWO FACES OF DEMOCRACY

As more of the world's nations turn to democracy, interest in alternative constitutional forms and arrangements has expanded well beyond academic circles. In countries as dissimilar as Chile, South Korea, Brazil, Turkey and Argentina, policy makers and constitutional experts have vigorously debated the relative merits of different types of democratic regimes. Some countries like Sri Lanka, have switched from parliamentary to presidential constitu-On the other hand, Latin Americans in particular have found themselves greatly impressed by the successful transition from authoritarianism to democracy that occurred in the 1970s in Spain, a transition enhanced by that country's parliamentary form of government.

Nor is Spain the only nation in which parliamentarism has given evidence of its worth. Indeed, the vast majority of the stable democracies in the world today are parliamentary regimes, where executive power is generated by legislative majorities and depends on such majorities for survival. By contrast, the only presidential democracy with a long history of constitutional continuity is the United States. The constitutions of Finland and France are hybrids rather than true presidential systems.

Parliamentary regimes, of course, can be unstable, especially under conditions of bitter ethnic conflict, as recent African history attests. Yet the experiences of India and of some English-speaking countries in the Caribbean show that, even in greatly divided societies, periodic parliamentary crisis need not turn into full-blown regime crises and that the ousting of a Prime Minister and Cabinet need not spell the end of democracy itself.

The superior historical performance of parliamentary democracies is no accident. A careful comparison of parliamentarism with presidentialism leads to the conclusion that, on balance, the former is more conducive to stable democracy than the latter. This conclusion applies especially to nations with deep political cleavages and numerous political parties; for such countries, parliamentarism generally offers a better hope of preserving democracy.

ELECTED BY THE PEOPLE A parliamentary regime in the strict sense is one in which the only democratically legitimate institution is parliament; in such a regime, the government's authority is completely dependent upon parliamentary confidence. Although the growing personalization of party leadership in some parliamentary regimes has made Prime Ministers seem more and more like Presidents, it remains true, that barring the dissolution of parliament and call for new elections, Premiers cannot appeal directly to the people over the heads if their representatives. Parliamentary systems may include Presidents who are elected by direct popular vote, but they usually lack the ability to compete seriously for

power with the Prime Minister. In presidential systems an executive with considerable constitutional powers - generally including full control of the composition of the cabinet and administration – is directly elected by the people for a fixed term and is independent of parliamentary votes of confidence. He is not only the holder of executive power but also the symbolic head of state and can be removed between elections only by the drastic step of impeachment. In practice, as the history of the United States shows, presidential systems may be more or less dependent on the cooperation of the legislature; the balance between executive and legislative power in such systems

can thus vary considerably.

Two things about presidential government stand out. The first is the President's strong claim to democratic, even plebiscitarian, legitimacy; the second is the fixed term in office. Both of these statements stand in need of some qualification. Some presidents gain office with a smaller proportion of the popular vote than many Premiers who head minority cabinets, although voters may see the latter as more weakly legitimated. Following British political thinker Walter Bagehot, we might say that a presidential system endows the incumbent with both the "ceremonial" functions of a chief executive, thus creating an aura, a self-image, and a set of popular expectations regardless of the victory margin which are all quite different from those associated with a Prime Minister, no matter how popular.

Employers Confederation, Khrystle Rutherford-Ferguson; and Chairman, Bahamas Entrepreneurial Venture Capital Fund Mike Cunningham.

Ms. Grant explained that it is the goal of the SBDC to continue serving those clients it had before the storm while creating opportunities for other existing MSMEs to bounce back even better than before.

"I need to emphasise this. We will continue to take care of our existing clients. What is being discussed today is additional resources that have allocated by our government and our partnering financial institutions to help the 2,525 active MSMEs across Abaco and Grand Bahama, employing approximately 4,000 people."

She said the government is providing five million dollars to guarantee up to 6.7 million dollars in loans through the Banks Clearing Association. Two million will be given equity in partnerships and 1.3 million in microloans and grants.

Ms. Grant stated that businesspersons placed will fill out an application form. That form will be looked over and an executive summary created by volunteer advisors. Those summaries and supporting

documents will then be sent to the relevant banks.

The form and list of documents needed is available on www.accessaccelerator.org under the title Resources, in a tab called Dorian.

She noted that it is anticipated that the process will take no more than 10 business days and disbursements for grants and microloans will be processed in four to five business days.

Mrs. Grant said displaced businesspersons who are currently in Nassau will be processed at the Edmund Moxey Centre on Baillou Hill Road.

In Grand Bahama persons can go to the BAIC building initially, until the one-stop shop is established at the CLICO building, for assistance.

In Abaco, the NIB/Inland Revenue building will be made available.

The SBDC Executive Director noted that for businesses that have been in operation for less than three years, attendance at a three-day seminar would be required for them to access these opportunities as well.

The Bahamas Chamber of Commerce will verify the authenticity of businesses seeking to access funding in order to ensure transparency and accountability.

More relief will soon be on the way to Abaco and Grand Bahama as the Bahamas Red Cross works to unload a 20-foot container full of supplies from Consolidated Water (Bahamas) Ltd. (CWCO). GBPA to Offer Economic Relief Assistance Programs

Business owners set to benefit from economic relief assistance programs following on-going consultation with the Grand Bahama Port Authority, Limited (GBPA).

As local businesses begin recovery and restoration plans following the impact of Hurricane Dorian, the Grand Bahama Port Authority, Limited (GBPA) seeks to engage with licensees to assess their needs. Deann Seymour, Chief Financial Officer and Licensing Chairman of the GBPA, says, "We recognize that many of our licensees face the daunting task of rebuilding. Our commitment is to provide the necessary support for their recovery that will translate into our island's economic sustainability and demonstrate Grand Bahama's resilient spirit."

The organization's further executive acknowledged that business owners were impacted on multiple levels with physical damage to commercial and residential property, in addition to employees who lost their homes, vehicles and other resources.
